Draft Explosives (Jersey) Law 201-</p> <p>The Panel approved the first draft of comments in response to P.96/2014 which had been lodged by the Minister for Home Affairs. It was noted that the proposition failed to include the notification of Constables in Article 23 and the Minister had been notified of the concerns of the Panel. It was clear that an amendment was needed either by the Minister or by the Panel to rectify the problem. The Panel was awaiting a response from the Minister.</p>	MR
<p>Item 1 28.05.14 516/40</p>	<p>3. Trackers Apprenticeship Programme.</p> <p>Following the public hearing with Mr. M. Burton, Chairman of the Jersey Construction Council, Education, Training and Professional Development sub-committee, the Panel agreed to meet the apprentices who had responded to an advertisement to discuss Trackers from their point of view. They were to meet on the evening of Wednesday 4th June at an informal venue.
