#### Report

The Committee is not proposing to increase the permit fees in respect of clubs, charities and organizations in connection with their fund-raising activities, contained in the Gambling (Gaming and Lotteries) (Jersey) Regulations 1965, as amended.

Some of these fees will have remained unchanged for six years, as many, due to the low level of fees charged of £5 and £10, form a very small percentage of the Committee's income, and it sees this as a way of supporting those connected in fundraising through such activities as bingo, lotteries, crown and anchor and cinema racing.

The Committee proposes, however, to increase Bookmakers Licence Fees for 2001 onward in line with current States policy, reflecting an annual increase of 2.5 per cent, and equal to 7.5 per cent over three years. The increases would apply to the 29 licensed betting offices, the four licensed credit betting office, and the two licensed amusement premises in the Island.

The last review was in 1997, which affected fees payable for 1998, 1999 and the year 2000.

The majority of increases are contained in the Gambling (Licensing Provisions) (Jersey) Regulations 1965, as amended. The proposed increases are as follows -

- (a) a bookmaker's licence from £240 to £258;
- (b) an amusement premises licence from £1,200 to £1,290;
- (c) a betting office/credit licence from £1,200 to £1,290;
- (d) a track licence from £360 to £387.

These Regulations have no implications for the financial or manpower resources of the States. The increases are in accordance with the agreed policy of the Finance and Economics Committee.

## **Explanatory Note**

The purpose of these draft Regulations is to increase the fees payable in respect of the grant or renewal of an amusement premises licence, a betting office licence, a bookmaker's licence and a track licence by, on average, 7.5%. The fees were last increased in 1997.

**THE STATES,** in pursuance of Article 3 of the Gambling (Jersey) Law 1964,  $^{[1]}$  as amended, have made the following Regulations -

- 1. For the First Schedule to the Gambling (Licensing Provisions) (Jersey) Regulations 1965, as amended, there shall be substituted the Schedule set out in the Schedule to these Regulations.
  - 2. The Gambling (Licensing Provisions) (Amendment No. 10) (Jersey) Regulations 1997 shall be repealed.
- **3.** These Regulations may be cited as the Gambling (Licensing Provisions) (Amendment No. 12) (Jersey) Regulations 2000 and shall come into force on the first day of January 2001.
