REPORT

I'm concerned that the helpful amendment recently promoted by the Deputy of St. Martin will exclude those members of the public who wish to renew their licence before the expiry date but who also wish to delete a category (I refer to category C– heavy goods).

It's quite common for those people who are at an age where medical reports have to be submitted with their licence to opt to remove that category when they no longer need it in order to avoid the inconvenience and expense of a medical examination.

I believe the wording of the new Article 3(3CA) of the Road Traffic (Jersey) Law 1956 excludes those people and thereby forces them to wait until their licence expires before they can renew it, unlike those who wish to renew but make no changes. My amendment therefore seeks to remove this anomaly.

There are no financial or manpower implications for the States arising from this amendment.

Explanatory Note

These Regulations amend the Road Traffic (Jersey) Law 1956 with the effect that a person's driving licence may be renewed for a period which is the aggregate of the remainder of the period of validity of his or her current licence and the period of 5 years, or such shorter period as applies in his or her case, notwithstanding that, or renewal, the categories of vehicle that the person is authorized to drive are reduced.

THE STATES, in pursuance of the Order in Council of 26th December 1851^[1] and Article 49 of the Road Traffic (Jersey) Law 1956,^[2] have made the following Regulations –

1 Interpretation

In these Regulations “Law” means the Road Traffic (Jersey) Law 1956.^[3]

2 Article 3 amended

In Article 3(3CA)(a) of the Law,^[4] for the words “without any alteration to the class or description” there shall be substituted the words “without any addition to the classes or descriptions”.

3 Citation and commencement

These Regulations may be cited as the Road Traffic (No. 56) (Jersey) Regulations 200 and shall come into force 7 days after they are made.
