Draft Opticians (Registration) (Amendment No. 2) (Jersey) Law 201- P.120/2016

 - (f) Medicines (Prescription Only) (Jersey) Order 1997, Article 1(1), in the definition "registered ophthalmic optician" and Schedule 2, entry 5, column 3.
- (2) In the following places for the words "ophthalmic opticians" there shall be substituted the word "optometrists"
 - (a) Medicines (Pharmacy and General Sale Exemptions) (Jersey) Order 1997, Schedule 1, Part 1, entry 2, column 1;
 - (b) Medicines (Prescription Only) (Jersey) Order 1997, Schedule 2, entry 6, column 1.
- (3) In the following places for the word "optician" there shall be substituted the words "optometrist, dispensing optician"
 - (a) Data Protection (Jersey) Law 2005, Article 1(1), in the definition "health professional";
 - (b) Stamp Duties and Fees (Jersey) Law 1998, Schedule 1, Part 1, entry 8.

(4) In the Social Security (Health Bonus Scheme) (Jersey) Regulations 2016, Regulation 1, in the definition "optician" for the words "person registered as an optician under" there shall be substituted the words "registered optician within the meaning of".".
