REPORT

The purpose of this Appointed Day Act is to bring into force the remaining provisions of the Jersey Overseas Aid Commission (Jersey) Law 2005. The Law was adopted by the States on 16th March 2005 and registered in the Royal Court after being sanctioned by the Privy Council on 19th August 2005.

The Law sets out the procedure for the appointment of the initial members of the Commission. That process began on 13th September 2005 when Deputy J.J. Huet was appointed as Chairman designate by the States. The Law requires the Chairman designate to select two States members to be Commissioners and three other persons to be non-States Commissioners. Once the selections have been made the nominations must be presented to the States for approval.

An advertisement was placed in the Jersey Evening Post inviting nominations for the three non-States Commissioner posts. The selection process will be managed by the Chairman designate with the assistance of the Chairman of the Jersey Appointments Commission. It is anticipated that the nominations will be presented to the States on 1st November 2005 and the effect of this Appointed Day Act is to bring the Law fully into force 7 days after the appointment of the last Commissioner is made. If the nominations presented by the Chairman designate of the Commission are approved on 1st November 2005 the Law will therefore come into force on 8th November 2005 at which time the Overseas Aid Committee will be abolished and its functions transferred to the Commission.

There are no additional financial or manpower implications arising from the adoption of this Appointed Day Act.

Explanatory Note

This Act brings into force, 7 days after the date on which the last member of the Jersey Overseas Aid Commission is appointed by the States under the Jersey Overseas Aid Commission (Jersey) Law 2005, those provisions of that Law that did not come into force 7 days after the Law was registered.

THE STATES, in pursuance of Article 7(3) of the Jersey Overseas Aid Commission (Jersey) Law 2005, [1] have made the following Act –

1 Commencement of Law

All the provisions of the Jersey Overseas Aid Commission (Jersey) Law 2005 that are not already in force shall come into force 7 days after the date on which the last person is appointed by the States to be a Commissioner in accordance with Part 1 of Schedule 2 to the Law.

2 Citation

This Act may be cited as the Jersey Overseas Aid Commission (Jersey) Law 2005 (Appointed Day) Act 200-.
