Advocates examinations: Statement

The President of the Legisation Committee made a statement in the following terms -

`On 31st March 1992, the Legislation Committee lodged `au Greffe' the draft Advocates (Amendment No. 3) (Jersey) Law 199 (P.43/92). The draft Law proposes certain amendments to the Advocates (Jersey) Law 1968, including a provision that, in future, a Jersey solicitor wishing to practice as an advocate must obtain a `Certificat d'études jurisdiques Françaises et Normandes' or, an equivalent.

Members will recall that in 1989 this House approved the Advocates (Amendment No. 2) (Jersey) Law 1990, which introduced the requirement that aspiring advocates should, with effect from 1st January 1991, obtain from the University of Caen a Certificate of Studies in Norman and French Law as part of their qualification for becoming an advocate. There was a transitional period of two years, the effect of which was that what has become known as the `Caen requirement' became compulsory as from 1st January 1993. Together with the Caen requirement a new and more restricted syllabus for the advocates' examination was published. In June of this year four Jersey students attended Caen University and, having completed the course obtained the Certificat.

In April 1992, Senator R.J. Shenton presented and lodged `au Greffe' two further projets. The first (P.52/92) in effect proposed that the Caen requirement be abolished. The second (P.62/92) requested the Legislation Committee to present an amendment to the Advocates (Jersey) Law 1968 to remove the Caen requirement and, following a Statement by the then President of the Legislation Committee, the late Deputy E.J. Becquet, it was agreed that discussions would be held with the Law Society and the University of Caen to review the Caen requirement. On 26th May 1992 Senator Shenton lodged a further amendment which had been presented to the States by the Legislation Committee (P.77/92) the effect of which was to request the Legislation Committee to investigate, in consultation with the Law Society of Jersey, the desirability of amending the Advocates (Jersey) Law 1968 to remove the Caen requirement. None of these projets have yet been debated by the House.

The Legislation Committee immediately established the required Working Party, initially under the chairmanship of the late Deputy Becquet and more recently under my chairmanship. The Working Party included the Vice President of the Legislation Committee, Senator R.R. Jeune, O.B.E., and three representatives nominated by the Law Society, Advocates A.J. Olsen, G.R. Boxall and A.R. Binnington. It was advised by the Attorney General.

A copy of the Working Party's report has today been tabled (R.C.36/93). In summary, the Working Party recommends that a 'twintrack' system of study and examination, whereby students may elect either to obtain the Certificat from Caen University, or study for an alternative certificate in Jersey covering the Law of Contracts and related Obligations and the principles and sources of Norman Customary Law. The report was unanimously endorsed by all members of the Working Party, including the representatives of the Law Society. As a matter of courtesy a copy of the report was sent to the Law Society since which my Committee has held a number of meetings with representatives of the Society. In addition, I was invited to attend an Extraordinary General Meeting of the Law Society at which the Society resolved to request the States to remove the Caen requirement.

My Committee is mindful of the importance of maintaining the Island's close and customary links with France and, in particular those with Caen University in Normandy. My Committee also wishes to record its appreciation to Le Doyen de la Faculté de droit et des sciences politiques of Caen University for his help and cooperation in providing a course of study relevant to the needs of Jersey. My Committee, therefore, has no hesitation in recommending that we should encourage the continuation of the Certificat at Caen University. However, it recognises the strong feelings expressed by the Law Society of Jersey and, having taken further advice, now recommends the removal of the mandatory requirement to obtain the Certificat.

My Committee has, therefore, accepted the recommendations of the Working Party to introduce the 'twin-track' system, thereby giving students an alternative and, effectively, abolishing the Caen requirement. It would, nevertheless, be irresponsible to merely remove one element of the examination process without introducing the Jersey study and examination alternative.

My Committee has, therefore, invited the Royal Court to pass an amendment to the Advocates (Examinations) (Jersey) Rules 1989 to establish the alternative Jersey Certificate. I am advised that the appropriate amendments can be in place so that students wishing to be examined after 1st January 1995, will be able to study for the alternative Jersey certificate. I should perhaps add that in accordance with the Advocates (Jersey) Law 1968, a period of 12 months must elapse before any new rules become effective and that it is for this reason that my Committee is anxious to ensure that the changes are in place before the end of this year.

I have asked the States to agree to debate the Advocates (Amendment No. 3) (Jersey) Law at its next Sitting on 7th December. As referred to at the beginning of this Statement the main purpose of the Amendment is to provide that a Jersey solicitor wishing to practice as an advocate must obtain the Certificat from Caen University or the alternative certificate outlined above. My Committee believes that it is proper that in future all persons wishing to qualify as advocates of the Royal Court should obtain one or other of these certificates and it is for this reason that I will propose the amendment. Furthermore, my Committee is very conscious of the uncertainty as to the future which has been facing Law students since the Caen requirement was called into question and it is time that this uncertainty was brought to an end.

Finally, I should add that my Committee has for some time been considering a more unified system of examinations for both advocates and solicitors. I was pleased to note the recommendation of Sir Godfrey Le Ouesne's Legal Practice Committee, that there should be one examination for the two branches of the profession. The Legislation Committee will, therefore, ensure that the review of the advocates examination syllabus referred to earlier in this statement will encompass the recommendation that the examination and syllabus for both advocates and solicitors is addressed. I am pleased to be able to report that I have received the assurance from the Law Society that they will appoint members to a further Working Party without delay to consider the appropriate changes."

Representations should be addressed to the Committee through the Office of the Chief Adviser."
