REPORT

In pursuit of the Committee's policy to manage the fishery of ormers, it is necessary to restrict the export of frozen ormers and to confine both the export of fresh ormers and the period of possession of ormers on a boat to times when fishing for ormers is permitted.

Financial and manpower implications

These Regulations have no additional financial or manpower implications for the resources of the States.

Explanatory Note

These Regulations amend Regulation 4 of the Sea Fisheries (Miscellaneous Provisions) (Jersey) Regulations 1998 (which contains restrictions relating to ormers) to impose a total ban on the export of ormers that are not fresh ormers and to confine the export of fresh ormers and the period for possession of ormers on a boat to the period when fishing for ormers is permitted.

THE STATES, in pursuance of Articles 2, 5, 8 and 22 of the Sea Fisheries (Jersey) Law 1994, $^{[1]}$ having consulted with the Secretary of State and obtained his concurrence, have made the following Regulations -

- 1. In Article 4 of the Sea Fisheries (Miscellaneous Provisions) (Jersey) Regulations 1998, $\frac{[2]}{2}$ as amended
- (a) in paragraph (3)(b)(i) for the words "sub-paragraph (a)" there shall be substituted the words "sub-paragraphs (a) and (c);
- (b) for paragraph (3)(b)(ii) there shall be substituted the following clause-
 - "(ii) for the purposes of sub-paragraph (b) of paragraph (1), where the possession is on a vessel, one of th three days immediately following such a day and where the possession is on land, one of the five days immediately following such a day.";
- (c) after paragraph (3) there shall be added the following paragraph-
 - "(4) No person shall export from the Island an ormer that is not a fresh ormer.".

2. These Regulations may be cited as the Sea Fisheries (Miscellaneous Provisions) (Amendment No. 3) (Jersey) Regulations 200- and shall come into force on the seventh day after they are made by the States.
