## Explanatory Note regarding subordinate legislation tabled at this meeting.

### R&O.30/2009.

This Order replaces the Motor Vehicles (Wearing of Seat Belts) (Jersey) Order 1999 (a separate Order relates to children under 14). The change effected by the Order is to extend the requirement for a person aged 14 or over to wear a seat belt. The requirement applies to all seats fitted with seat belts, instead of only to certain front seats, and passengers must use any available seat fitted with a belt.

The Order was made on 20th March 2009 and comes into force on 3rd April 2009.
