DRAFT REGULATION OF CARE (JERSEY) LAW 2014 (APPOINTED DAY) ACT 201-

REPORT

The Draft Regulation of Care (Jersey) Law 2014 (Appointed Day) Act 201- brings into force, on 1 January 2019, those Articles of the [Regulation of Care \(Jersey\) Law 2014](#) which have not yet been enacted (*see* [L.42/2014](#)). Those Articles will, in turn, bring into force the Regulations listed below, once they are adopted by the States Assembly. The following draft Regulations are lodged for debate on the same date as this draft Appointed Day Act –

- Draft Regulation of Care (Regulated Activities) (Jersey) Regulations 201- (P.126/2018)
- Draft Regulation of Care (Standards and Requirements) (Jersey) Regulations 201- (P.127/2018)
- Draft Regulation of Care (Transfer of Functions) (Jersey) Regulations 201- (P.128/2018)
- Draft Regulation of Care (Transitional and Transfer) (Jersey) Regulations 201- (P.129/2018).

Financial and manpower implications

Information about the financial and resource implications of enacting the remaining Articles of the 2014 Law is set out Section 4 of the report accompanying the Draft Regulation of Care (Regulated Activities) (Jersey) Regulations 201-.

Explanatory Note

This Act brings into force the remaining provisions of the Regulation of Care (Jersey) Law 2014 and will enable the Law to be fully functional as a framework for the regulation of activities involving or connected with the provision of health or social care.

The Law was adopted by the States on 3rd July 2014 and was registered by the Royal Court on 14th November 2014. The following provisions came into force the day after registration –

- (a) Article 1;
- (b) Article 2 and Schedule 1;
- (c) Article 3(6);
- (d) Articles 10 and 11;
- (e) Articles 14 to 16;
- (f) Article 30(3);
- (g) Part 7 and Schedule 2;
- (h) Article 49; and
- (i) Article 50.

1 Appointed day

The provisions of the Regulation of Care (Jersey) Law 2014², other than those set out in Article 50(2) of that Law, shall come into force on 1st January 2019.

2 Citation

This Act may be cited as the Regulation of Care (Jersey) Law 2014 (Appointed Day) Act 201-.
