Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O.47/2006

This Order provides for the closing of public roads and other public places for the holding of the Battle of Flowers on Thursday 10th August 2006 and the Moonlight Parade on Friday 11th August 2006.

It also sets out conditions relating to these closures and other arrangements in connection with the events.

The Order was made by the Minister for Transport and Technical Services on 18th May 2006.

R&O.48/2006

This Order prohibits any vehicle from waiting on the west side of La Ruelle es Ruaux, between a point 25 yards south of its junction with Le Mont des Vignes and Blanc Pignon, for more than 12 hours in any period of 24 hours.

It also prohibits vehicles wider than 6 feet 6 inches from using La Rue du Craslin between Ruelle du Marais and Les Grupieaux.

The Order was made on 18th May 2006, and comes into force 7 days later.
