Report

The existing Customs and Excise (General Provisions) (Jersey) Law was enacted in 1972. It was, however, based on 1952 United Kingdom legislation, which was itself the product of a long history of addition, amendment, duplication and ambiguity. The Customs and Excise (Jersey) Law 1999 integrates the General Provisions Law with the various old and outdated Excise Laws which date back to 1845.

The main aims of this Law are to -

- improve provisions relating to smuggling and fraud;
- clarify the implementation of Jersey's relationship with the European Community as far as customs matters are concerned;
- remove a whole raft of outdated and bureaucratic provisions; and
- introduce readily accessible and flexible rules regarding excise duty.

The draft Law was debated and approved by the States on 13th April 1999, sanctioned by Order of Her Majesty in Council of the 24th day of November 1999 and registered in the Royal Court on 24th December 1999.

Explanatory Note

The purpose of this Act is to appoint 1st November 2000 as the day for the commencement of most of the provisions of the	ıe
Customs and Excise (Jersey) Law 1999. The Law was adopted by the States on 13th April 1999 (P.21 of 1999).

THE STATES, in pursuance of Article 74 of the Customs and Excise (Jersey) Law 1999, [1] have made the following Act -

- 1. The Customs and Excise (Jersey) Law 1999 shall come into force on the first day of November 2000 with the exception of the following provisions -
 - (a) Article $19^{[2]}$ and
 - (b) those parts of Part I of the Fourth Schedule that relate to the repeal of the Import and Export (Control) (Jersey) Law $1946^{[4]}$ and parts of the Finance (Jersey) Law $1998.^{[5]}$
 - 2. This Act may be cited as the Customs and Excise (Jersey) Law 1999 (Appointed Day) Act 2000.
