Caesarean Croquet and Lawn Tennis Club. Questions and answers (Tape No. 88)

Deputy Maurice Clement Buesnel of St. Helier asked the Connétable of St. John, President of the Island Development Committee, the following questions -

- ``1. Has the President and his Committee concluded their discussions with the Caesarean Croquet and Lawn Tennis Club regarding the removal of the dome from its premises in Grands Vaux?
- 2. If the answer is in the affirmative, could the President say when the residents of Grands Vaux can expect the removal of this unsightly structure?"

The President of the Island Development Committee replied as follows -

``1. No. The States, on 20th

November 1990, asked the Island Development Committee to negotiate with the club with a view to the dismantling and removal of the airdome. In that debate, the States were informed that the club had no wish to remove the dome and that if its removal were to be achieved then it would have to be through the relocation of the club in its entirety, probably to the land zoned for recreational use at Bel Royal. The States were reminded that the club had first sought to erect a permanent building to house two indoor courts, but in view of the States' wish to relocate the club (having zoned the site of the club for Category A housing in the Island Plan), the Committee had decided to allow an airdome instead, which was capable of relocation and which in any case had a limited lifespan. The Attorney General advised the States that the Committee had no recourse under the Island Planning Law to revoke its decision as the works were complete.

In the wake of the States' decision, the club formed a small sub-committee to discuss the matter, and the Acting Director of the Planning Department and myself met that committee in February. We discussed the wishes of the club for the future and its preparedness to relocate its facilities. The sub-committee reiterated its view that it had no specific wish to relocate, but was prepared to ask its membership to consider doing so if it was the wish of the States, subject to the proviso that it should not suffer any penalty - either financially or in the quality and extent of the facilities it enjoyed.

Relocating the indoor facility in the short term, with the remainder of the facilities following later, was not considered viable or desirable in terms of the club's operation. It would mean maintaining two sites and duplicating changing and social facilities, which could not be successfully managed by the club.

2. My Committee is currently preparing its development plans for the Bel Royal and Beaumont areas and expects this work to be finished by the late summer. On this basis we will be able to make positive recommendations to the States. I must warn the Deputy and other members that the relocation of the club will be contingent on the States' agreeing to allocate sufficient capital resources to the project, and to that extent the timing of the removal of the airdome from Grands Vaux is not something that my Committee can predict."
