# States of Jersey Development Company: Pre-Sales Provisions for Residential Developments and Pre-Let(s) Provisions for Commercial Developments P.88/2024

THE STATES commenced consideration of a proposition of the Council of Ministers entitled 'States of Jersey Development Company: Pre-Sales Provisions for Residential Developments and Pre-Let(s) Provisions for Commercial Developments' (P.88/2024) and, adopting an amendment of the Council of Ministers (P.88/2024 Amd.) agreed that, for the words "sufficient level of legally binding pre-sales in line with" there should be substituted the words "minimum of 25% of the Gross Development Value as legally binding pre-sales and meet".

THE STATES, adopting the proposition of the Council of Ministers, as amended, agreed that the States of Jersey Development Company Limited would accord with the following pre-sales provisions for residential developments and pre-let(s) provisions for commercial developments –

"If it is proposed that a specific development is undertaken directly by the States of Jersey Development Company Limited, before committing to construction costs the States of Jersey Development Company Limited will, on a residential development, have to secure a minimum of 25% of the Gross Development Value as legally binding pre-sales and meet third party funding requirements or, on a commercial development, a sufficient level of legally binding pre-let(s) that, together with the unlet space, will deliver an end value of the completed building that exceeds the costs of constructing the development. This will remove part of the sales/letting risk of a particular development project."
