Sixth Form College - question and answer (Tape No. 275)

Deputy Alastair John Layzell of St. Brelade asked the Connétable of St. Lawrence, President of the Education Committee the following question -

"Will the President assure the House that those members of the Working Party presently studying the feasibility of a Sixth Form College, who might ultimately disagree with the conclusions of that Working Party, will be given every opportunity to publish their own minority report in the interests of conducting a fully informed debate on this vital matter?"

The President of the Education Committee replied as follows -

"The question posed by Deputy Layzell presupposes that members of the working party of officers and senior teaching staff may wish to disagree with its conclusions.

The group is working in a constructive and collaborative manner and it is my hope that they will continue to do so and reach full agreement. Should this not be achieved then any member of the working party would be entitled to present a minority report which would be included in the publication containing the group's findings."

16+ education - questions and answers. (Tape No. 275)

Senator John Stephen Rothwell asked the Connétable of St. Lawrence, President of the Education Committee the following questions -

- ``1. What is the policy of the Education Committee on teachers becoming involved publicly in political matters?
- 2. Was the Committee aware that the heads of the four 11-16 secondary schools (feeder schools) had written to parents on the subject of the 14+ transfer to Hautlieu School? If so, did the Committee authorise them to do so?
- 3. Will the report prepared by the teachers of Hautlieu School in response to the OFSTED study be released in its entirety to States' members?
- 4. In order to allay confusion that appears to exist amongst the general public, would the President say whether -
  - (a) her Committee has determined a policy with regard to the future of Hautlieu and 16+ education in Jersey; and
  - (b) if, or when, the Committee has determined that policy she will present to the States a clear statement of that policy; of the likely timetable for any proposed changes necessary to implement that policy; and the cost and manpower implications?"

The President of the Education Committee replied as follows -

- ``1. While guidelines are issued to staff requiring that they should do nothing in their professional capacity nor in their private lives to bring discredit on the service, no policy on teachers becoming involved publicly in political matters has ever been established. However, since September 1994 the Director, at the request of the Education Consultative Council and a number of headteachers, has been involved in discussions with headteachers and teacher representatives with a view to recommending a policy to the Education Consultative Council. His recommendations will be presented to its next meeting which will be held on 8th June 1995.
- 2. The answer to both questions is "No".
- 3. It is a matter for the teachers of Hautlieu School to decide whether to release their response to the Ofsted report to States' Members. My Committee, whilst not endorsing their report, has given approval to the staff for its publication.
- 4. Members will be aware that my Committee has commissioned a working party comprised of officers and the senior staff from the five secondary schools who are producing an action plan for the establishment of a Sixth Form College. A brief has been agreed by the group and this includes detailed consideration of staffing and resource implications as well as a timetable for implementation. Their report will be presented to my Committee on 26th April 1995, following which we will decide upon our policy and the content of the report and proposition to be laid before the States.

It is not my intention that any change would be implemented before the new town secondary school opens. This will not be before September 1997 at the earliest and may not be until 1998. Hautlieu will continue as a 14-18 school until that time."
