## Report

The purpose of this Act is to appoint 1st July 2002 as the day for the commencement of the majority of the provisions of the Telecommunications (Jersey) Law 2002, a Law adopted by the States on 31st July 2001 (P.103/2001).

The provisions deal with the licensing and other functions of the Jersey Competition Regulatory Authority under that Law, and set out the framework for the transfer of the operations of the existing Telecommunications Board to a new company licensed under that Law.

The Act would permit the JCRA to accept licence applications from potential operators in the telecommunications market and to enter into formal consultation on such applications.

Failure to appoint 1st July 2002 as the day for the commencement of the relevant provisions would potentially result in missed opportunities for investment in the Island's telecommunications infrastructure.

This draft Act has no implications for the financial or manpower resources of the States.

## **Explanatory Note**

The purpose of this Act is to appoint 1st July 2002 as the day for the commencement of the majority of the provisions of the Telecommunications (Jersey) Law 2002, a Law adopted by the States on 31st July 2001 (P.103 of 2001) and registered in the Royal Court on 4th January 2002.

The provisions deal with the licensing and other functions of the Jersey Competition Regulatory Authority under that Law, and set out the framework for the transfer of the operations of the existing Telecommunications Board to a new company prescribed under that Law.

**THE STATES,** in pursuance of Article 68 of the Telecommunications (Jersey) Law  $2002_{7}^{[1]}$  have made the following Act -

  - (a) Parts 1, 3, 4, 5, 7 and 8;  $^{[2]}$
  - (b) Articles 54 61, 63 65 and 68; [3]
  - (c) Article 67, to the extent that it relates to paragraph 7 of Schedule 2;  $\frac{[4]}{}$
  - (d) Schedule 2, to the extent of paragraph 7. [5]
  - 2. This Act may be cited as the Telecommunications (Jersey) Law 2002 (Appointed Day) Act 200-.
