## Report

In 1951 the number of Centeniers for the Parish of St. Saviour was increased from two to four. Almost fifty years have since elapsed in which the population of St. Saviour has increased dramatically and the complexion of the Parish has been radically transformed. The Legislation Committee agrees with the Connétable of St. Saviour that the quota of four Centeniers is now inadequate in such a populated and urbanised Parish.

It falls to the Legislation Committee to sponsor the legislation necessary to increase the number of Centeniers of St. Saviour and it is proposed that the number be increased to six. The draft Law follows the time-honoured format of legislation enacted for such purposes.

The Parish Assembly gave its approval to the proposal on 10th March 1997 and it is understood that there are two candidates of appropriate calibre willing to offer themselves for election.

The proposal has also been referred to the Defence Committee which has expressed no objection. The proposal is further supported by the *Comité des Connétables*.

If this Law is adopted and duly sanctioned by Her Majesty, the Honorary Police of St. Saviour will number -

6 Centeniers  
6 Vingteniers  
20 Constable's Officers

**Explanatory Note**

The purpose of this Law is to increase from four to six the number of Centeniers for the parish of St. Saviour.

In translation, the Law reads as follows -

**THE STATES**, subject to the sanction of Her Most Excellent Majesty in Council, have adopted the following Law -

**ARTICLE 1**

The number of Centeniers for the parish of St. Saviour is increased to six. The new Centeniers will have the same term of office, duties to fulfil and rights as the existing Centeniers.

ARTICLE 2

This Law may be cited as the Law (199 ) concerning the Honorary Police of St. Saviour.”.
