**Explanatory Note regarding subordinate legislation tabled at this meeting.**

**R & O 106/2001**

This Order authorizes the Classic and Vintage Motor Racing Club of Jersey to hold motor races on roads comprising the Five Mile Road course on 31st August 2001 and the Grève de Lecq course on 1st September 2001.

The times at which the roads may be closed and used for those purposes are specified in the Order.

The Order was made by the Home Affairs Committee on 12th July 2001 under the Motor Vehicle Races (Jersey) Law 1946.
