Road Traffic (Public Parking Places) (Jersey) Amendment Order 2025. *Minister for Infrastructure*.

This Order amends the Road Traffic (Public Parking Places) (Jersey) Order 2006 to -

- (a) increase parking charges (both unit costs and season tickets) by 2.5% (though when GST is taken into account, the increase is actually 2.88%);
- (b) remove references to the lower parking changes and first year exemption from charges that applied to electric vehicles and plug in hybrid electric vehicles up to the end of 2024.

Opportunities have been taken to remove a now redundant saving provision relating to electric vehicles and plug in hybrid electric vehicles, and to update a missed reference to the Minister for Education and Lifelong Learning.

The Order was made on 28th March 2025 and comes into force on 1st April 2025.

Companies (GAAP) (Jersey) Amendment Order 2025.

Minister for External Relations.

This Order amends Article 2 of the Companies (GAAP) (Jersey) Order 2010 to prescribe the UK-adopted international accounting standards (UK IAS) as an additional generally accepted accounting principle and standard for market traded companies for the purposes of Article 105 (accounts) of the Companies (Jersey) Law 1991, for the preparation of accounts for a financial period starting on or after 1 April 2025.

These standards were adopted for use in the United Kingdom for financial years beginning on or after 1 January 2021 under Part 2 of the International Accounting Standards and European Public Limited-Liability Company (Amendment etc.) (EU Exit) Regulations 2019 of the United Kingdom (S.I. 2019/685).

The Order was made on 31 March 2025 and came into force on 1 April 2025.
