#### R&O.92/2018.

Sea Fisheries (Bag Limits) (Amendment No. 2) (Jersey) Order 2018.

This Order amends the Sea Fisheries (Bag Limits) (Jersey) Order 2016 to set the bag limit for blue fin tuna at zero fish on any day.

Article 2 gives the title of this Order and provides that it will come into force on the day after it is made.

The Order was made on 13th September 2018 and came into force on 14th September 2018.

#### R&O.93/2018.

European Union (Repeal and Amendment) (Jersey) Law 2018 (Commencement) (Jersey) Order 2018.

This Order brings into force, on the day after it is made, all but 4 of the Articles of the European Union (Repeal and Amendment) (Jersey) Law 2018, which was registered by the Royal Court on 1st June 2018.

There are 2 pairs of Articles of the European Union (Repeal and Amendment) (Jersey) Law 2018 that are not brought into force at this stage. One is Articles 2 and 3, which would repeal the European Union (Jersey) Law 1973 and the European Economic Area (Jersey) Law 1995. The other is Articles 6 and 7, which would remove the power to make Orders to implement EU sanctions (or to give further effect to directly applicable EU legislation), and would make other amendments to the power to make Regulations under Article 2 of the European Union Legislation (Implementation) (Jersey) Law 2014. Those provisions can be brought into force at a later date by a subsequent commencement Order or Orders.

The main provision brought into force by this Order is Article 9, which inserts new Articles 5A and 5B into the European Union Legislation (Implementation) (Jersey) Law 2014. The new Articles 5A and 5B enable the States Assembly to make Regulations to deal with deficiencies in Jersey legislation arising from the withdrawal of the United Kingdom from the European Union, and to prevent or remedy breaches of international obligations arising from such a withdrawal or other relevant change. The effect of commencing Article 9 is to enable those Regulations to provide that they should come into force before the remainder of the Law where necessary (in particular before the repeal of the current legislation giving effect in Jersey to EU law – see above).

The Order also commences Articles 1, 4, 5, 8, 10 and 11 of the Law. Those Articles mainly support the effect of Article 9, particularly by updating interpretation provisions, but also allow the States Assembly to make consequential Regulations (and transitional, incidental, supplementary or savings provisions by Regulations) that flow from the amendments that are brought into force at this stage.

The Order was made on 18th September 2018 and came into force on being made.

#### R&O.94/2018.

Taxation (Exchange of Information with Third Countries) (Amendment of Regulations) (Jersey) Order 2018.

This Order amends the Schedule to the Taxation (Exchange of Information with Third Countries) (Jersey) Regulations 2008 to insert items and entries relating to Chile and Spain in the list of third countries with which Jersey has taxation exchange of information agreements.

The Order was made on 18th September 2018 and came into force on 19th September 2018.

#### BRITISH-IRISH PARLIAMENTARY ASSEMBLY

Following the recent elections it is necessary to appoint a Member and an Associate Member to represent the States of Jersey on the British-Irish Parliamentary Assembly (BIPA). Senator J.A.N. Le Fondré was appointed as Member during the term of the last States Assembly with Deputy K.C. Lewis of St. Saviour as the Associate Member. The Associate Member is invited to attend meetings of BIPA if the Member is unavailable.

Nominations will firstly be invited from the floor at the meeting for the position of Member and each nomination will need to be seconded (in accordance with Standing Order 102). If there is more than one nomination, a secret ballot will be held. If no candidate receives a majority of votes cast in the ballot the candidate with the lowest number of votes will withdraw from the contest and a further secret ballot will be held. This process will be repeated as necessary until one candidate receives a majority of votes cast.

Nominations will then be invited from the floor for the position of Associate Member. The selection process will be identical to the process set out above.

Those appointed will remain in office until the election of 2022.

#### **Background Information**

Jersey was invited to join the British-Irish Inter-Parliamentary Body (as BIPA was known until 2008) in 2000 although Jersey's initial involvement was limited. The history of the Body is available on its website (www.britishirish.org).

The running of the Body and the control of its business is in the hands of a Steering Committee consisting of 3 Members from Dublin, 3 from Westminster, and 3 from among the other participating institutions, led by the 2 Co-Chairmen, one from Westminster and one from Dublin. The 3 Crown Dependencies have one place on the Committee between them and this is filled on an annual rotation basis. Jersey has filled the Crown Dependency place on the Committee in 2017 and will next do so in 2020.

The Body is funded by grant-in-aid from the Treasury in London and the Department of Finance in Dublin. The day-to-day administration is carried out by 2 Clerks, one from Dublin and one from Westminster, with assistance from several of their colleagues from both jurisdictions.

There are normally 2 Plenary sessions every year, of a day and a half or 2 days each, which provide a forum for the mutual exchange of views between parliamentarians. The practice to date has been to alternate Plenaries between Ireland and the UK (although one plenary was held in the Isle of Man in 2010) and they have usually been held at venues other than Dublin and London. Each Plenary has a Question Time at which a Minister from the host country answers Questions (of which notice is given in the Programme of Business) put by Members of both parliaments - which can lead to a Minister from one jurisdiction having to deal with extremely probing supplementaries from Members from the other. Apart from the Ministerial Statement and Questions, the main business is always a debate on a motion on Recent Political Developments. At first, those debates were held in private on the grounds that politicians from Ireland and Great Britain would feel inhibited about discussing sensitive issues with journalists in attendance. Once the Body found its feet, however, it became routine to hold all debates in public, even those on sensitive security issues; and a private sitting is now a very rare event - and then only to discuss domestic, organisational matters.

The primary function of Plenary Sessions is to provide a forum for debate and the exchange of views, while the day-to-day work of the Body is carried out through its 4 Committees: Committee A deals with Sovereign (i.e. East-West) Matters, Committee B covers European Affairs, Committee C is concerned with Economic Affairs, and Committee D with Environmental and Social Affairs. Each Committee has a



Chairman from one delegation and a Shadow Chairman from the other, so that the British and the Irish each have 2 full Chairmanships. They are supported by 4 Clerks from Westminster and, from the Irish side, 2 officers from the Department of Foreign Affairs. The Steering Committee assigns each full Member of the Body and each Associate to one of the 4 Committees, normally by agreement with the person concerned, and with an eye both to party-political balance and equality of representation from the delegations. Jersey did not initially participate in Committee work but after his appointment in 2013 then Deputy Le Fondré became a member of Committee C.

The total membership of the Body at present is –

- 25 members of the Oireachtas (plus up to 20 Associate members);
- 25 members of the UK Parliament (including peers) (plus up to 20 Associate members);
- 5 members of the National Assembly for Wales (plus up to 4 Associate members);
- 5 members of the Northern Ireland Assembly (plus up to 4 Associate members);
- 5 members of the Scottish Parliament (plus up to 4 Associate members);
- one member of Tynwald (plus one Associate member);
- one member of the States of Jersey (plus one Associate member);
- one member of the States of Guernsey (plus one Associate member).

In recent years Jersey has been represented by former Senator A. Breckon (2006 to 2012), the late Connétable D.J. Murphy of Grouville (2012 to 2013) and Senator Le Fondré (2013 to date). All have attended Plenary sessions on a regular basis and have made useful contacts for the Island.

The cost of participation is not excessive with the only expense being the fares and hotel accommodation which are paid by each jurisdiction and not by the host. The External Relations Department has made an officer available to accompany Jersey's Member to recent plenary sessions and this has been done at the expense of that Department.

"Will the Minister advise what percentage of commuters cycle to work in St. Helier and what measures (both short and long term) are being taken to improve and encourage day-to-day cycling provision in Jersey?"

"Will the Chief Minister provide a full list of Assistant Ministers, including any delegated responsibilities they may have, as well as the dates on which the decisions to make them Assistant Ministers and to delegate them any responsibilities were signed?"

- (b) if such use is monitored, what the current level of food bank use is in Jersey; and
- (c) what measures, if any, will be taken in both the short and long terms to reduce and remove the need for food banks in the Island?"

"Will the Chief Minister indicate whether he was consulted prior to the recent decision to sign a Memorandum of Understanding with a leading blockchain operator to set up a Sterling / Cryptocurrency exchange in Jersey and can he advise what compliance research, due diligence or Know Your Customer checks were accomplished; and, if it is not himself, will the Chief Minister advise the Assembly who is accountable for that Memorandum and whether there is any linked current, or future, financial liability for the States of Jersey?"

"Further to Summary Table C ('Summary of Approved Central Contingency Allocations for 2017-2019') in the Medium Term Financial Plan Addition 2017-2019 and in light of 'Contingency Allocation: Revised Policy – August 2018' (R.112/2018), will the Minister –

- (a) provide an updated table showing how much of each contingency allocation has been spent to date; and
- (b) explain, in respect of the £13.5 million allocated for the Economic Productivity and Growth Drawdown Provision (EPGDP),:
  - i. what amounts, if any, from the EPGDP have either been spent so far or been moved to other areas of contingency or to the Consolidated Fund; and



- ii. what the future plans are for the EPGDP?"
- 10. The Minister for Health and Social Services will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"In respect of mental health services, will the Minister –

- (a) inform members what targets, if any, he has for increasing the number of mental health nurses, therapists and doctors in child and adult mental health services in Jersey;
- (b) state what vacancies are currently being carried in these services and what the current vacancy rate is; and
- (c) state what measures, if any, he has in place or under consideration to improve recruitment and retention in mental health services, especially such services for children and young people?"
- 11. The Minister for Education will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Will the Minister give a full breakdown of departmental funding for 2018 for States non-fee-paying primary and secondary schools, including the A.W.P.U. (age weighted pupil unit) rate and the total per school as well as any additional funding for elements such as the Jersey Premium or S.E.N. (Special Education Needs) / E.S.L. (English as a Second Language) provision?"

12. The Chief Minister will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Further to his response to Written Question 118/2018, will the Chief Minister advise whether funding has now been identified to enable Statistics Jersey to run an Income Distribution Survey this year and, if not, will he explain why not?"

13. The Minister for Children and Housing will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Will the Minister inform members of the number of social rental homes sold off from the stock of Andium Homes over the period of its existence in comparison with the number of such homes sold off by the former Department of Housing over the equivalent period of time before incorporation; and will he also provide the financial and political justification for these sales by Andium Homes?"

14. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Will the Minister, as shareholder representative, inform members of –

(a) the total number, and cost, of parking spaces provided by Andium Homes and other social housing providers, with the information broken down by site / estate showing the number of spaces allocated to residents of the estate, those allocated to others who reside in the locality and those which are rented to the general public; and



- (b) what measures, if any, are in place to monitor the performance of G4S in administering and enforcing the parking permits system following the outsourcing of that service on Andium sites?"
- 15. The Minister for Environment will table an answer to the following question asked by Deputy C.S. Alves of St. Helier –

"What plans, if any, does the Minister have for encouraging the use of ground-based photovoltaic (PV) arrays on brown field sites?"

16. The Minister for Infrastructure will table an answer to the following question asked by Deputy C.S. Alves of St. Helier –

"Will the Minister provide a list of States-owned buildings in which asbestos is present; and will he advise –

- (a) how, if at all, users of, and workers in, these buildings are informed of the location of asbestos; and
- (b) what precautions are put in place to minimise exposure to asbestos by the people within these buildings?"
- 17. The Minister for Social Security will table an answer to the following question asked by Deputy C.S. Alves of St. Helier –

"Will the Minister consider the introduction of a Jersey equivalent to the U.K.'s 2008 'Diffuse mesothelioma payments scheme' and, if so, can she estimate what the annual cost of introducing such a scheme in the Island would be?"

18. The Minister for Education will table an answer to the following question asked by Deputy C.S. Alves of St. Helier –

"What is the current level of headroom funding in the Island's 11 to 16 schools?"

19. The Minister for Health and Social Services will table an answer to the following question asked by Deputy M. Tadier of St. Brelade –

"Will the Minister explain whether there are any plans to ban the sale of tobacco in Jersey on health grounds and, if not, why not; and will he further explain what is the official advice from his Department as to the safe level of smoking?"

20. The Minister for Health and Social Services will table an answer to the following question asked by Deputy M. Tadier of St. Brelade –

"Further to recent changes to legislation to ban smoking in cars where children are present, will the Minister advise –

- (a) how many convictions there have been to date, if any; and
- (b) whether there any similar plans to protect children from second hand smoke in their own homes, and, if not, why not?"



21. The Minister for the Environment will table an answer to the following question asked by Deputy M. Tadier of St. Brelade –

"Further to the findings of tests carried out on behalf of the Department of the Environment that showed that levels of NO<sub>2</sub> in the Tunnel were up to 7 times higher than those recorded at Snow Hill, is it the Minister's assessment that people walking and cycling through the Tunnel are safe; and, if not, what action will he take to safeguard the health of these categories of commuters?"

22. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy M. Tadier of St. Brelade –

"Further to the response to Oral Question 102/2018, will the Minister confirm the number of Jersey taxpayers living overseas deemed to have been adversely affected by the removal of marginal relief for non-resident pensioners; and will she advise what steps she is currently taking, if any, to address the concerns raised by this group of people?"

23. The Chairman of the States Employment Board will table an answer to the following question asked by Deputy L.M.C. Doublet of St. Saviour –

"Further to the previous Chief Minister's response to Oral Question 1(171) of 14th March 2017 regarding the application of policies in States of Jersey work places to assist breastfeeding mothers in their return to work, what States of Jersey workplaces now offer breastfeeding facilities, such as a lockable room with a fridge, comfortable seating, a sink and plug socket?

Please detail in a table all workplaces and state which facilities are available, or 'none'."
