#### **REPORT**

**Decision(s):** Under Standing Order 168(3) the Minister for Treasury and Resources hereby notifies the States that he has accepted the recommendation of the Property Holdings Department to agree to the following –

#### (a) Land transaction –

- (1) To approve a contract with Saint Meen Properties Ltd. and the Trustees of Beaulieu Convent School to acquire and grant access rights to/from Beaulieu and to agree maintenance arrangements for the new traffic scheme, with Beaulieu's costs to be met by the Public.
- (2) To confirm the above decision after giving the States 15 working days notice of the transaction, and to cause the transaction to be completed.

After the expiry of 15 days following presentation to the States the transaction may be concluded.

## (c) Land transaction –


- (1) To approve the leasing out of Maison St. Louis Observatory Flat for a period of 3 years, with effect from 1st November 2010.

After the expiry of 15 days following presentation to the States the transaction may be concluded.


