Explanatory Note

These Regulations would have the following effect -

- (a) They increase from £36 to £37 the fee payable on the first examination of a vehicle for its suitability as a public service vehicle, and to one half of that amount the fee payable by an unsuccessful applicant who re-submits his vehicle for another examination within 30 days.
- (b) They increase from £5 to £10 the fee for replacing a lost or defaced licence plate for a public service vehicle.
- (c) They increase the fees payable by applicants for licences to drive public service vehicles in the following ways -
 - (i) from £58 to £60 for each practical test;
 - (ii) from £47 to £48 for the cab driver's test on knowledge of the Island;
 - (iii) from £31 to £32 for the char-à-banc driver's test on knowledge of the Island; and
 - (iv) from £7.40 to £7.60 on other applications to drive public service vehicles

The Regulations would come into force on 1st January 1999.

THE STATES, in pursuance of Articles 49A and 54 of the Motor Traffic (Jersey) Law 1935, as amended, have made the following Regulations -

- 1. In Regulation 1 of the Public Service Vehicles (Fees) (Jersey) Regulations 1991,² as amended³ (hereinafter referred to as "the principal Regulations"), for the amount "£36" in each place where it occurs there shall be substituted the amount "£37".
- **2.** For the amount "£5" in Regulation 3 of the principal Regulations there shall be substituted the amount "£10".
 - 3. In Regulation 4 of the principal Regulations -
 - (a) in paragraph (a) -
 - (i) for the amount "£58" in clause (A) there shall be substituted the amount "£60";
 - (ii) for the amount "£47" in clause (B) there shall be substituted the amount "£48":

- (iii) for the amount "£31" in clause (C) there shall be substituted the amount "£32";
- (b) in paragraph (b), for the amount "£7.40" there shall be substituted the amount "£7.60".
- 4. The following Regulations are repealed -
- (a) the Public Service Vehicles (Fees) (Amendment) (Jersey) Regulations 1992;⁴
- (b) the Public Service Vehicles (Fees) (Amendment No. 8) (Jersey) Regulations 1997.5
- 5. These Regulations may be cited as the Public Service Vehicles (Fees) (Amendment No. 9) (Jersey) Regulations 1998 and shall come into force on the first day of January 1999.
