"What pre-application advice, if any, was given by the Minister and/or the Department in respect of removing Field 528, St. Saviour, from the Green Zone?

3. The Deputy of St. John will ask the following question of the Chief Minister –

"Would the Chief Minister inform members how many public employees received Voluntary Redundancy (VR) packages as part of the recent scheme and whether any of these have now reached retirement age, and, if so, would he advise why these employees were granted Voluntary Redundancy?

4. Deputy S.S.P.A. Power of St. Brelade will ask the following question of the Minister for Planning and Environment –

"The draft Island Plan in its present form proposes, in Policy NE6, a Coastal National Park; can the Minister confirm the manpower and financial implications that will arise if this proposal is approved and will he clarify whether more staff will be required at the Environment Department?"

5. The Deputy of St. Mary will ask the following question of the Chief Minister-

"Can the Chief Minister advise members what steps, if any, Ministers have taken to bring forward a coherent plan to create jobs in methods of reducing energy demand, such as insulation of buildings and increased efficiency in our transport arrangements; energy demand management; alternative energy production, thus creating savings in years to come in both carbon emissions and financial terms, and creating much needed sustainable jobs?"

6. Deputy P.V.F. Le Claire of St. Helier will ask the following question of the Minister for Transport and Technical Services –

"Would the Minister explain what is happening at La Collette in respect of the development and management of green waste facilities, what new cement laying and works are being carried out and at what cost?"

7. Deputy G.P. Southern of St. Helier will ask the following question of the Minister for Social Security –

"Given that the first 6 month period is vital to the well being of babies can the Minister justify his proposals for maternity leave?

8. Deputy T.M. Pitman of St. Helier will ask the following question of the Minister for Social Security –

"Given that the contributions of those made redundant through no fault of their own are protected by Social Security, why are such individuals subsequently accepting short term contracts in trying to improve their chances of re-gaining full-time employment then penalized once these contracts end by losing this contribution protection; further still, how does this encourage people to work rather than exist on benefits?" 9. Deputy G.P. Southern of St. Helier will ask the following question of the Minister for Social Security –

"Would the Minister state whether the recently announced proposals to extend the retirement age will simply transfer the costs from the pension fund to income support or long term incapacity allowance?"

10. The Deputy of St. Mary will ask the following question of the Minister for Health and Social Services –

"What financial and other support was provided to ACET year by year from the department from 2008 to the present day and what work did this support, and is the Minister satisfied that ACET will receive adequate support this year to allow all its programmes to continue, and if not, will this work be replaced and, if so, how, and what risk analysis was carried out before funding was cut?"

11. Deputy T.M. Pitman of St. Helier will ask the following question of the Minister for Treasury and Resources –

"Following statements from his Assistant Minister that a confidential report indicating that 1 (1)(k) residents bring a financial benefit in excess of £50 million cannot be released to members to enable them to verify these claims, will the Minister agree to release the document under the Code of Practice on access to information and, if not, does he accept that this will only cast doubt on the validity of such claims?"

12. Deputy S.S.P.A. Power of St. Brelade will ask the following question of the Minister for Economic Development –

"Following the announcement that the wholesale price of milk is to increase by 5p per litre on 9th May (or by about 5%) can the Minister explain why the efficiencies created by a new dairy facility at Trinity are not being reflected in lower milk prices as was claimed would be the case when the States were asked to agree to facilitate the move of the dairy to Trinity?"

R&O.43/2011.

This Order amends the Community Provisions (Restrictive Measures – Côte d'Ivoire) (Jersey) Order 2011 to take account of amendments to the relevant EU Regulation by Council Implementing Regulation (EU) No. 85/2011 of 31 January 2011 and Council Regulation (EU) No. 330/2011 of 6 April 2011. It also gives th Chief Minister a power, rather than a duty, to notify the Commission and Member States of certain matters, and allows the Chief Minister to disclose certain information to the Jersey Financial Services Commission.

The Order was made on 8th April 2011 and came into force on 9th April 2011.

R&O.44/2011.

This Order allows Jersey International Air Display a.r.l. to control access to certain roads and beaches on 7th, 8th and 9th September 2011 for the viewing of the Jersey International Air Display.

The Order was made on 15th April 2011 and came into force on being made.

R&O.45/2011.

This Order substitutes paragraph 5 of Schedule 2 to the Income Support (General Provisions) (Jersey) Orde 2008 in order to increase certain amounts and percentages of amounts that are disregarded when assessing the weekly income of a household for the purposes of calculating the income support payable to the household.

The new paragraph 5 embodies the following changes-

- (a) in paragraph 5(a), the disregarded percentage of earnings of an adult in a household who is *not* entitled to a sole adult's basic component (under Article 5(2)(b) of the Income Support (lersey) Law 2007) rises from 16.5% to 20%;
- (b) in paragraph 5(h), where 2 formulae are compared in the calculation of the disregarded percentag of earnings of an adult in a household who *is* entitled to such a sole adult's basic component, the formula that refers to total earnings also rises from 16.5% to 20%;
- (c) in paragraph 5(f), the disregarded amount "100% of the first £35.98" [of income derived from a pension or annuity of one person in a household who is aged at least 65] is increased, by £1.82, to "100% of the first £37.80";
- (d) in paragraph 5(g), the disregarded amount "100% of the first £22.40" [of income derived from a pension or annuity of any other person in a household who is aged at least 65] is increased, also by £1.82, to "100% of the first £24.22".

The Order was made on 18th April 2011 and will come into force on 1st June 2011.

R&O.46/2011.

This Order increases fees in the following enactments -

Animal Welfare (Licence Fee) (Jersey) Order 2008 Dangerous Wild Animals (Jersey) Law 1999 Artificial Insemination of Domestic Animals (Bovine Semen) (Jersey) Order 2008 High Hedges (Application Fee) (Jersey) Order 2008 Waste Management (Fees) (Jersey) Order 2008 Planning and Building (Fees) (Jersey) Order 2008.

The increases, the first since 1st January 2010, are generally around 2.5%.

In a few cases the old and new fees are not strictly comparable. In Schedule 1 (planning permission) to the Planning and Building (Fees) (Jersey) Order 2008, the fees in relation to dwellings will be calculated on the basis of their floor area (instead of on the basis of a flat fee). Moreover, the fee will vary according as there are one or more dwellings (instead of up to 5, or more than 5, and whether they are flats or houses).

In Schedule 2 (building permission) to the same Order, the fees for the creation of new flats and new dwelling houses will in future be calculated on the basis of the simple number of flats or houses, rather than differently according as there are up to 5 or more than 5 flats or houses.

Certain fees will not change, notably the building permission fees for certain modifications of existing structures.

The Order was made on 18th April 2011 and came into force on 2nd May 2011.

R&O.47/2011.

This Order revises the transitional arrangements relating to the introduction of income support. The Order extends the transitional periods of protection for individuals formerly entitled to attendance allowance in respect of a child member of the household.

The Order was made on 19th April 2011 and comes into force on 1st July 2011.

R&O.48/2011.

This Order allows the Jersey Motor Cycle and Light Car Club to hold motor rallies on Saturday 9th July 2011 on 3 courses in the parish of St. Ouen.

The Order was made on 19th April 2011 and came into force immediately upon being made.

R&O.49/2011.

This Order gives effect in Jersey to Council Regulation (EU) No. 359/2011 of 12 April 2011concerning restrictive measures directed against certain persons, entities and bodies in view of the situation in Iran. This Order also amends the disclosure provisions contained in the Community Provisions (Restrictive Measures – Iran) (Jersey) Order 2010 to align them with similar provisions in this Order and, in particular, to expressly enable information to be disclosed by the Chief Minister to the Jersey Financial Services Commission for the purpose of any of its functions, where the Chief Minister believes the exercise of such a function may assist in achieving compliance with the Council Regulation.

The Order was made on 20th April 2011 and came into force on 21st April 2011.

R&O.50/2011.

This Order gives effect in Jersey to Council Implementing Regulation (EU) No. 360/2011 of 12 April 201 which amends Regulation (EU) No. 204/2011 concerning restrictive measures in view of the situation inLibya (OJ No. L100/12, 14.4.2011). The Council Implementing Regulation amends the lists of persons and entities against whom sanctions are imposed in view of the situation in Libya.

The Order was made on 20th April 2011 and came into force on 21st April 2011.

R&O.51/2011.

This Order prescribes simple interest of 2 percentage points above the Barclays Bank plc base rate as the rate of interest that a limited partner must pay under Article 15 or Article 18 of the Separate Limited Partnership (Jersey) Law 2011.

Article 15 relates to a limited partner's liability to repay, with up to 6 months' interest, profits paid to him or her while a separate limited partnership is insolvent.

Article 18 relates to a limited partner's liability to repay, with up to 6 months' interest, any part of his or her contribution to the partnership that is returned to the partner while the partnership is insolvent.

The Order was made on 20th April 2011 and will come into force on the same day as those Articles of the Law.

R&O.52/2011.

This Order prescribes simple interest of 2 percentage points above the Barclays Bank plc base rate as the rate of interest that a limited partner must pay under Article 13 or Article 16 of the Incorporated Limited Partnership (Jersey) Law 2011.

Article 13 relates to a limited partner's liability to repay, with up to 6 months' interest, profits paid to him or her while a incorporated limited partnership is insolvent.

Article 16 relates to a limited partner's liability to repay, with up to 6 months' interest, any part of his or her contribution to the partnership that is returned to the partner while the partnership is insolvent.

The Order was made on 20th April 2011 and will come into force on the same day as those Articles of the Law.

R&O.53/2011.

This Order further amends the Community Provisions (Restrictive Measures – Burma/Myanmar) (Jersey) Order 2008 (the "principal Order") in order to give effect in Jersey to Commission Implementing Regulation (EU) No. 383/2011 of 18 April 2011 (OJ Nd. 103/8, 19.4.2011). The Commission Implementing Regulation amends Council Regulation (EC) No. 194/2008, which imposes restrictive measures in respect o Burma/Myanmar, by amending the lists of enterprises, Government officials and other persons against whom restrictions are imposed. This Order also amends the disclosure provisions contained in the principal Order to align them with similar provisions made in respect of other restrictive measures Orders and, in particular, expressly enables information to be disclosed by the Chief Minister to the Jersey Financial Services Commission for the purpose of any of its functions, where the Chief Minister believes the exercise of such a function may assist in achieving compliance with the Council Regulation.

The Order was made on 21st April 2011 and came into force on 22nd April 2011.
