REPORT

On 18th June 2024, the Minister for the Environment made a Ministerial Decision delegating certain of his functions under Articles 28, 30 and 30A of the [States of Jersey Law 2005](#) (see Decision reference MD-ENV-2024-474, available at www.gov.je).
