Item 4 29.11.07	<b>Population Register Proposals –</b> Received transcripts from the Public Hearings held with the Migration Advisory Group and the Data Protection Commissioner on the 20 <sup>th</sup> December.  Panel noted and discussed a summary document prepared by its adviser based on the information discussed during the hearings. It was agreed that the Panel still had outstanding queries regarding the following issues:  1. Clarification as to who will have responsibility for the Jersey Names and Address Index and the Population Register.  2. Confirmation as to whether an Identity Card debate is likely to be brought to the States.  3. Costs of collecting new data to populate the database, rather than the current proposal to use existing data.  4. How it is proposed to address the problem posed by the uncontrolled housing market, and accurately measuring the number of individuals falling within that section of the population.  5. Information on the software proposed to be used to complete the matching process, including its past success rate.  6. How many records exist in each of the databases that are

What the implications of using new data would have on timescales for forming the register.</p> <p>9. Clarification as to the formal de-registration process proposed for the database.</p> <p>10.
