### **R&O.99/2022.**

Road Traffic (Public Parking Places) (Amendment No. 17) (Jersey) Order 2022.

*Minister for Infrastructure.*

This Order amends the Road Traffic (Public Parking Places) (Jersey) Order 2006 to provide for a temporary Shopper Zone on level 2 of the Pier Road Car Park in St. Helier. The changes come into effect on the day after the Order is made, and cease to have effect at midnight on 31st July 2023.

This Order comes into force on the day after it is made.

The Order was made on 22nd November 2022 and came into force on 23rd November 2022.

### **R&O.101/2022.**

Control of Housing and Work (Fees) (Amendment No. 5) (Jersey) Order 2022.

*Chief Minister.*

This Order amends the Control of Housing and Work (Fees) (Jersey) Order 2013 to increase, by 2.5% in each case, fees in relation to applications for registration cards, consent to acquire land, business licences, non-resident trading licences and non-resident hawker's licences, and annual charges in respect of Licensed persons and Registered persons. The increases come into effect on 1st January 2023.

The Order was made on 25th November 2022 and comes into force on 1st January 2023.

### **R&O.102/2022.**

Infrastructure (Driver and Vehicle Standards – 2023 Fees) (Jersey) Order 2022.

*Minister for Infrastructure.*

This Order increases certain fees charged by Driver and Vehicle Standards, by approximately 2.5%. It also increases the fee charged by the provider of the compulsory basic training course by 8.2%, in line with contractual arrangements.

The majority of the fees increased by this Order were previously increased with effect from 1st January 2022. The fees under the Road Traffic (Periodic Technical Inspections – Fees) (Jersey) Order 2019 have not previously been increased.

This Order comes into force on 1st January 2023.

The Order was made on 29th November 2022 and comes into force on 1st January 2023.

### **R&O.103/2022.**

Motor Vehicles (Driving Licences) (Amendment No. 18) (Jersey) Order 2022.

*Minister for Infrastructure.*

This Order amends the Motor Vehicles (Driving Licences) (Jersey) Order 2003 (“2003 Order”) in 2 respects: (a) by broadening the evidence which may be acceptable to the Inspector of Motor Traffic



("Inspector") before a person takes a driving theory test or a driving practical test and (b) by extending the list of countries issuing driving licences that may be exchanged for a Jersey driving licence.

*Article 1* provides that this Order amends the Motor Vehicles (Driving Licences) (Jersey) Order 2003.

*Article 2* amends the 2003 Order so that if an applicant for a driving theory test is unable to meet the current requirement to produce a driving licence authorising the applicant to drive the vehicle in which the practical test will take place, the Inspector may accept any evidence that the Inspector considers satisfactory.

*Article 3* amends the 2003 Order so an applicant for a driving practical test is no longer required to produce an insurance certificate for the vehicle in which the test is to take place. Instead, the applicant must sign a declaration, with the examiner present, that such an insurance policy is in force. A further amendment is made by Article 3 so that if the applicant is unable to meet the current requirement to produce a certificate showing that the applicant has successfully passed the theory test, the Inspector may accept any evidence that the Inspector finds satisfactory.

*Article 4* amends how categories of vehicle in Jersey are specified to make clear that a category which includes a "+" sign may be shown with or without the "+" sign. This is to ensure consistency with how vehicle categories are shown in Jersey driving licences and in Schedule 5.

*Article 5* amends Schedule 5 to the 2003 Order by extending the list of countries issuing driving licences that may be exchanged for a Jersey driving licence to include the Cayman Islands, United Arab Emirates, Taiwan, Ukraine, and North Macedonia. Article 5 also amends Schedule 5 by removing some drafting inconsistencies and references to driving licences that are no longer in use.

*Article 6* sets out the title of this Order and provides for it to come into force 7 days after it is made.

The Order was made on 29th November 2022 and came into force on 6th December 2022.

#### **R&O.104/2022.**

Home Affairs (Fire and Rescue and Petroleum) (2023 Fees) (Jersey) Order 2022.

*Minister for Home Affairs.*

This Order increases the fees payable under 3 other Orders.

- (a) Fees under the Fire Precautions (Fees) (Jersey) Order 2010 are increased by between 2% and 2.4%.
- (b) Fees under the Fire and Rescue Service (Charges) (Jersey) Order 2012 are increased by between 1.3% and 2.5%.
- (c) Fees under the Petroleum (Licensing) (Fees) (Jersey) Order 2012 are increased by between 2.2% and 2.5%.

The fees were last increased as of 1st January 2022.

The Order comes into force on 1st January 2023.

The Order was made on 29th November 2022 and comes into force on 1st January 2023.

#### **R&O.105/2022.**

Road Works (Permit Fees – Amendment No. 2) (Jersey) Order 2022.

*Minister for Infrastructure.*

This Order amends the Road Works (Permit Fees) (Jersey) Order 2019 to increase, by 2.5%, the fees required for a permit to carry out road works. These fees were last amended with effect from 1st January 2022.

This Order comes into force on 1st January 2023.

The Order was made on 1st December 2022 and comes into force on 1st January 2023.





**R&O.106/2022.**

Long-Term Care Services (Health and Social Services Charges) (Amendment No. 10) (Jersey) Order 2022.  
*Minister for Health and Social Services.*

This Order amends the Long-Term Care Services (Health and Social Services Charges) (Jersey) Order 2014 to increase, by approximately 12%, the charges specified in that Order for care services provided in a care home or group home.

The charges specified for each level of long-term care services have been calculated by adding the rate for long-term care benefit for the equivalent level of standard care, to the costs of living in an approved home, excluding incidental expenses. The rate for long-term care benefit is prescribed in Article 8 of the Long-Term Care (Benefits) (Jersey) Order 2014 (the “Benefits Order”), and the costs of living in an approved home are prescribed in Article 9(c) of the Benefits Order, and both are to be updated for 2023.

This Order comes into force on 1st January 2023.

The Order was made on 2nd December 2022 and comes into force on 1st January 2023.

**R&O.107/2022.**

Long-Term Care (Benefits) (Amendment No. 11) (Jersey) Order 2022.  
*Minister for Social Security.*

This Order amends the Long-Term Care (Benefits) (Jersey) Order 2014 to increase –

- the rates of long-term care benefit for weekly standard care costs for long-term care (specified in Article 8 of that Order), by approximately 12% (*Article 2*);
- the amounts that a person must pay towards the weekly costs of living in an approved home and for incidental expenses (specified in Article 9 of that Order), by approximately 10.4% (*Article 3*);
- the amounts that a person must pay towards the person’s standard care costs before the person qualifies to receive a long-term care benefit for standard care costs (specified in Article 10 of that Order), by approximately 12% (*Article 4*);
- the amount that may be loaned to a person to enable the person to pay the costs of living in an approved home (specified in Article 12 of that Order), by approximately 10.4% (*Article 5*).

The Order comes into force on 1st January 2023.

The Order was made on 2 December 2022 and comes into force on 1st January 2023.

**R&O.108/2022.**

Control of Housing and Work (Temporary Exemption – Amendment No. 3) (Jersey) Order 2022.  
*Chief Minister.*

The Control of Housing and Work (Temporary Exemption – Amendment No. 3) (Jersey) Order 2022 amends Article 5(2) of the Control of Housing and Work (Temporary Exemption) (Jersey) Order 2021 (the “2021 Order”) to provide for the 2021 Order to expire at the end of 31st December 2023 instead of at the end of 31st December 2022. The 2021 Order provides that, for a limited period, certain additional persons are to be disregarded for the purposes of complying with any condition which appears on a business licence granted under Article 27(1)(a) of the Control of Housing and Work (Jersey) Law 2012, concerning the



maximum number of individuals with Licensed or Registered status who are permitted to work for an undertaking.

This Order comes into force 7 days after it is made.

The Order was made on 7th December 2022 and comes into force on 14th December.

#### **R&O.109/2022.**

Non-Profit Organisations (Miscellaneous Amendments – Commencement of Law) (Jersey) Order 2022.

*Minister for External Relations and Financial Services.*

This Order brings the Non-Profit Organisations (Miscellaneous Amendments) (Jersey) Law 2022 into force on 1st January 2023.

The Order was made on 8th December 2022 and came into force on the same day.

#### **R&O.110/2022.**

Non-Profit Organisations (Prescribed NPOs – Additional Obligations) (Jersey) Order 2022.

*Minister for External Relations and Financial Services.*

The Non-Profit Organisations (Prescribed NPOs – Additional Obligations) (Jersey) Order 2022 is made under Article 13A of the Non-Profit Organizations (Jersey) Law 2008 (“the Law”).

*Article 1* of the Order provides the meaning of a prescribed NPO for the purposes of Article 13A of the Law.

*Articles 2 to 6* of the Order set out various obligations on prescribed NPOs that are additional to the obligations that apply to all NPOs under the Law. These obligations implement some of the recommendations made by the Financial Action Task Force in the interpretive note to Recommendation 8 of its Recommendations adopted on 16th February 2012.

The obligations include an obligation on prescribed NPOs to prepare an annual financial statement, an obligation to have appropriate accounting systems and controls, an obligation to keep and retain records of owners, controllers and other persons exercising significant influence or control over the activities of the prescribed NPO, an obligation to keep and retain a record of significant donors and obligations to identify and obtain information relating to associate NPOs and beneficiaries.

*Article 7* of the Order provides that it comes into force immediately after the Non-Profit Organisations (Miscellaneous Amendments) (Jersey) Law 2022 comes into force.

The Order was made on 8th December 2022 and comes into force on 1st January 2023.

“Will the Minister advise how many GP consultations have been conducted under the Health Access Scheme (HAS), broken down by month, since its launch in January 2021?”

5. The Minister for Social Security tabled an answer on 28th November 2022 to the following question asked by Deputy B.B. de S.DV.M. Porée of St. Helier South:

“Will the Minister advise –

- (a) which members of the public she will seek views from regarding the extension of discrimination legislation to include religious belief, and whether she intend to engage with minority groups;
- (b) whether she has consulted with any minority groups, or disability and inclusion led organisations, to best identify how to produce accessible communications and guidance notes; and
- (c) what methods she, or the Department, will be using to ensure communications and guidance is accessible to all Islanders, for example, will the Minister be providing information in multiple languages or in braille?”



6. The Chief Minister tabled an answer on 5th December 2022 to the following question asked by Deputy M.B. Andrews of St Helier North:

“Will the Chief Minister advise whether she is considering publishing gender pay gap reporting for each Government Department; and, if not, why not?”

7. The Chair of the States Employment Board tabled an answer on 5th December 2022 to the following question asked by Deputy M.B. Andrews of St Helier North:

“Will the Chair outline how many complaints in relation to bullying within the Government of Jersey have been received since 2017?”

8. The Minister for Health and Social Services tabled an answer on 5th December 2022 to the following question asked by Deputy M.B. Andrews of St Helier North:

“Will the Minister advise how many medical appointments for services offered by her Department have been cancelled in 2022?”

9. The Minister for Social Security tabled an answer on 5th December 2022 to the following question asked by Deputy M.R. Scott of St. Brelade:

“Given the existence of members of the public on a lower income who may not have access to the internet (and who may not be able to afford to purchase local newspapers), will the Minister provide information regarding any Government strategies that exist either to collect and access data on, or to make direct contact with, such members of the public in order that they are notified of, and assisted in applying for, any Government benefits such as the Community Cost Bonus to which they are entitled?”

10. The Minister for Home Affairs tabled an answer on 5th December 2022 to the following question asked by Deputy M.R. Scott of St. Brelade:

“Will the Minister explain what steps, if any, are being taken to address anti-social behaviour and vandalism in locations known in the Island for such behaviour (including Coronation Park, St. Brelade’s Bay and Havre des Pas) and to ensure that any perpetrators below adult age are either adequately supported or appropriately disciplined with consideration for their age and social circumstances?”

11. The Minister for Treasury and Resources tabled an answer on 5th December 2022 to the following question asked by Deputy L.V. Feltham of St. Helier Central:

“In light of statements on pages 8 and 9 of the proposed Government Plan 2023-2026 that many of the areas identified for growth funding will require further investment in future years of the Plan, but that Ministers had “constrained this growth until it is clear how such additional investment would be affordable”, will the Minister –

- (a) state what areas of Government were identified as requiring such additional funding and how much additional funding would be required in each area;
- (b) explain the rationale for not prioritising each area; and
- (c) detail the methodology used to prioritise the successful growth bids?”



12. The Minister for Housing and Communities tabled an answer on 5th December 2022 to the following question asked by Deputy S.Y. Mézec of St. Helier South:

“In relation to the proposed Rent Control Tribunal, will the Minister –

- (a) explain what advice, if any, he has received, either from his officers or from H.M. Attorney General as to the kinds of tenancies that will fall under the remit of the proposed Tribunal which he is seeking to establish under P.106/2022; and, if he did not seek any such advice, will he explain why not;
- (b) state whether tenancies established since the Residential Tenancy (Jersey) Law 2011 came into force will fall under the remit of the Tribunal under the powers it has pursuant to the Dwelling Houses (Rent Control) (Jersey) Law 1946;
- (c) explain whether tenancies with Andium Homes will be subject to the jurisdiction of the Tribunal; and
- (d) explain how many tenancies he estimates will have recourse to be considered by the Tribunal pursuant to the terms of both the 2011 Law and the 1946 Law?”

13. The Minister for the Environment tabled an answer on 5th December 2022 to the following question asked by Deputy M.R. Scott of St. Brelade:

“Will the Minister explain –

- (a) why the public consultations on the draft Supplementary Planning Guidance for ‘Housing Outside the built-up area’ and for ‘Density’ (both dated October 2022) were set for a 6-week period and how this relates to the requirements of Article 3 of the Planning and Building (Jersey) Law 2002 for the period in which representations can be made by the public;
- (b) how the proposed limits of 279 square metres (sq. m.) or 3,000 square feet (sq. ft.) gross internal floorspace within the first policy were decided upon;
- (c) why implementation of Recommendation 3.6 of the St. Brelade Character Appraisal with respect to footprint and height of replacement homes in areas outlined within the Baseline Report was not proposed in those draft policies;
- (d) what outcomes these policies are intended to achieve and how success is to be measured; and
- (e) whether the public responses to the consultations will be published and whether the States Assembly’s approval of these policies will be sought?”

14. The Minister for Social Security tabled an answer on 5th December 2022 to the following question asked by Deputy G.P. Southern of St. Helier Central:

“Will the Minister advise what measures, if any, she has under consideration to ensure the maintenance, or improvement, of high-quality G.P services (such as same day appointments) given the financial difficulties faced by G.P practices in the Island; and will she further advise of any face-to-face meetings she has had with G.P representatives to address their concerns about delivering high standards in primary care?”

“Further to the recent publicity stating that “severe mental stress” was caused to a benefit recipient resulting from the pursuit of an overpayment of benefit made in error by her Department, will the



Minister detail what measures she has taken, or intends to take, to eliminate such errors in future; and will she specifically advise to what extent overpayments are caused by staffing pressures in the delivery of Income Support awards?”
