Report

Explanatory Note

This Act specifies the countries and territories, in which the Convention on the Recognition and Enforcement of Decisions Relating to Maintenance Obligations (concluded at the Hague on 2nd October 1973) is in force, which are Hague Convention countries for the purposes of Part 4 of the Maintenance Orders (Facilities for Enforcement) (Jersey) Law 2000.
