 - (c) the fund to be set up with the transfer of the £32 million surplus funds currently available from the Dwelling House Loans Fund.
- 2. agreed that the Strategic Reserve Fund, established in accordance with the provisions of Article 4 of the Public Finances (Jersey) Law 2005, should be a permanent reserve, where the capital value is only to be used in exceptional circumstances to insulate the Island's economy from severe structural decline such as the sudden collapse of a major Island industry or from major natural disaster.
