Explanatory Note regarding subordinate legislation tabled at this meeting.

This Order amends the Employment (Minimum Wage) (Jersey) Order 2007 (the "principal Order").

Article 1 is an interpretation provision.

Article 2 amends Article 2 of the principal Order so as to substitute for the minimum wage of £5.40 an hour, the rate of £5.80 an hour. It also substitutes for the minimum wage for a trainee of £4.05 an hour, the rate of £4.35 an hour.

Article 3 deletes Article 4(2) of the principal Order. Article 4(2) requires employers to keep records of the actual number of hours worked by an employee during a pay reference period.

Article 4 provides for the citation of the Order and that it will come into force on 1st April 2008.

The Order was made on 28th November 2007 and comes into force on 1st April 2008.
