

**WRITTEN QUESTION TO THE CHIEF MINISTER
BY DEPUTY M.R. HIGGINS OF ST. HELIER
ANSWER TO BE TABLED ON MONDAY 14th DECEMBER 2015**

Question

Will the Chief Minister provide the following information for members for each States Department (breaking down the Chief Minister's Department into its individual operational or administrative units) for each year from 2008 to November 2015 -

- (a) every charge, fee or item that resulted in an increase income from members of the public or companies (ie. a charge by any other name) raised in that year together with its percentage rise; and,
- (b) the annual rate of inflation for each year (in the case of 2015 using November 2014 to November 2015)

Education, Sport and Culture

Nursery Education Fund

Fees introduced in September 2009 and increases capped at 2.5%.

Fee Paying Schools (Victoria College and JCG)

Fee increases since September 2007 have at times exceeded 2.5% to cover pay awards and minor capital projects.

In such cases fee increases have been approved by Ministerial Decisions signed by the ESC Minister and The Treasurer.

Jersey Music Service

Fees introduced in September 2014 with no increases for the academic year 2015-16.

Highlands College

All fee increases since 2008 in line with rate of 2.5% with 2 exceptions detailed on the attached. i.e. Higher Education Course Fees in 2012-13 and Part time Course fees in 2015-16.

Both increases approved by Ministerial Decisions signed by ESC Minister and The Treasurer.

Library

List of current fees attached. These have not be increased by more than 2.5% in any year since 2008.

Sport

Average increase in fees has not exceeded 2.5% since 2008, although some individual fees have increased by more than this.

The 2015 average increase is 2.4% and 2016 2%. A list of detailed fees by activity is in an attached spreadsheet.

Social Security Department

The department has two sources of external income: population office fees (which are managed by the Chief Minister’s Department) and Employment Agency Fees, which have not increased since 2008.

Chief Minister's Department

The new Control of Housing and Work (Jersey) Law, 2012, was effective from the 1st July, 2013, and introduced new fees by Order. This is the only external income received by the Chief Ministers Department from members of the public or companies.

Jersey Property Holdings

Jersey Property Holdings (JPH) manages the States of Jersey property portfolio, which includes managing and receiving property income charged to members of the public or companies. This will typically take the form of a rent for a lease or a license. As at June 2015 JPH had more than 200 agreements in place.

The leases and licenses are tailored to fit the specific details of the property. The majority of these agreements are linked to JRPI or to property rental market values, with a minority of agreements tailored for the circumstances of the property.

The details of the agreements between JPH as landlord and the tenants occupying the properties may contain commercially sensitive data and it is inappropriate for this data to be in the public domain.

The JPH property portfolio is constantly evolving as properties are disposed of, and it is therefore not possible to go back through eight years of individual property data to provide a percentage increase as requested by the Deputy.

Income received under some agreements managed by JPH is credited to other departments. For example, income from units in Fort Regent is received by the Education Sports and Culture Department and will be accounted for by those departments.

A total amount of income received in each year would not enable a comparison with inflation as variances between years will have a number of different causes. These include vacant properties, additions and disposals to the property portfolio, changes in use of property which may result in a new rental income and other changes when properties are re-let.

Taxes office

Late Filing Fee - Personal Tax

Maximum fee was £200 in 2008 and increased to a maximum of £250 in 2009 and is linked to the final tax liability

e.g.: tax liability £50 late filing fee £50

e.g.: tax liability £300 late filing fee £250

maximum fee increased by 25% from £200 in 2008 to £250 in 2009

ISE Annual Fee

Whilst it is termed as a fee, it is in reality the tax liability due for that year, and not something which is an increased income

If it is considered relevant, the fees increased on 1.1.12 as follows:

Deposit Taking banks increased from £30,000 to £50,000 (66%)

Other administered entities increased from £100 to £200 (100%)

Legal Fees - below amounts are as of 1st Jan 2012. Unable to find out what they were pre 2012 so unable to confirm if any changes between 2008 and 2011

When we issue a summons to take a taxpayer to court the following fees apply

Petty Debts Court

Up to £100 = £30

£100 to £500 = £60

£500 to £1,000 = £120

£1,000 to £2,500 = £180

£2,500 to £10,000 = £240

Royal Court

Over £10,000 = £300

When we take a tax payer to court a Stamp Duty fee applies

Petty Debts Court

Up to £100 = £7

£100 to £500 = £15

£500 to £1,000 = £30

£1,000 to £2,500 = £80

£2,500 to £10,000 = £120

Royal Court

Over £10,000 = £90

States Assembly

There has been no increase in the cost of publications sold by the States Greffe during this period. In fact the income from sales of publications has dropped since 2008 as the publications are mostly available on the internet or are free to the public.
