Explanatory Note regarding subordinate legislation tabled at this meeting.

R&O.6/2012.

This Order gives effect to Commission Implementing Regulation (EU) No. 7/2012 of 5 January 2012, which amends Council Regulation (EC) No. 1183/2005 of 18 July 2005 imposing certain specific restrictive measures directed against persons acting in violation of the arms embargo with regard to the Democratic Republic of the Congo by amending the list of persons in Annex I to that Council Regulation who are subject to the freezing of funds and economic resources.

The Order was made on 17th January 2012 and came into force on 18th January 2012.

R&O.10/2012.

This Order contains a direction by the Chief Minister under the Money Laundering and Weapons Development (Directions) (Jersey) Law 2012 ("Law"). Under Article 5 of that Law a direction may be made if certain conditions are satisfied. Both of the following conditions are satisfied: (a) the international body known as the Financial Action Task Force has advised that measures should be taken in relation to Iran because of the risk of money laundering; and (b) the Chief Minister reasonably believes that activity in Iran facilitating the development or production of nuclear weapons poses a significant risk to the interests of Jersey.

The direction is given to all "relevant persons" as defined in the Law. "Relevant person" means –

- (a) a person carrying on a financial services business in or from within Jersey; or
- (b) any of the following carrying on a financial services business in any part of the world
 - (i) a body incorporated in Jersey,
 - (ii) a limited liability partnership registered under the Limited Liability Partnerships (Jersey) Law 1997, or
 - (iii) a separate limited partnership registered under the Separate Limited Partnerships (Jersey) Law 2011.

The direction prohibits a relevant person from entering into new transactions or business relationships with banks incorporated in Iran, including their branches and the Central Bank of Iran, or continuing to participate in transactions or business relationships with such banks. Under Article 6(15) of the Law, the direction also prevents such transactions or business relationships from taking place with subsidiaries of such banks. Under Article 9 of the Law, the Chief Minister may grant a licence to exempt certain acts from these prohibitions.

Under Article 14 of the Law, a person who breaches a direction is guilty of an offence and liable to a maximum term of 2 years imprisonment and an unlimited fine.

This Order comes into force forthwith and, unless earlier revoked, will cease to have effect one year after it is made in accordance with Article 7(3) of the Law.

The Order was made on 19th January 2012 and came into force on being made.

R&O.11/2012.

These Rules amend the Immigration (Work Permits) (Jersey) Rules 1995 in order to require the Minister to take into account an entrant's knowledge of English (as well as the existing criteria) when deciding whether to issue a work permit to the entrant and to allow work permits to be issued up to 3 months in advance (instead of the current 2 months).

The Rules were made on 19th January 2012 and come into force on 1st March 2012.



R&O.12/2012.

This Order amends the Road Traffic (Public Parking Places – Charges) (Jersey) Order 2010 with effect from 1st February 2012.

The charges are increased by 3.9%, rounded up or down as appropriate. They were last increased on 1st February 2011.

The second amendment narrows the rule for eligibility to pay discounted parking charges. Currently, all vehicles which have emissions of no more than 100 grams of carbon dioxide per kilometre and hybrid vehicles that have emissions in excess of that amount but less than 120 grams qualify for discounted parking charges. The amendment restricts the eligibility of hybrid vehicles that have emissions in excess of 100 grams but less than 120 grams so that only those vehicles which are first registered before 1st July 2012 qualify.

The Order was made on 20th January 2012 and comes into force on 1st February 2012.

R&O.13/2012.

This Order increases the minimum wage by 2.5% with effect from 1st April 2012. The minimum wage was last increased on 1st April 2011.

The Order was made on 23rd January 2012 and comes into force on 1st April 2012.

R&O.14/2012.

This Order creates transitional arrangements for the valuation of benefits in kind taken into account as part of a Class 1 insured person's earnings or a Class 2 insured person's income from self-employment. For the first half of 2012, benefits in kind shall continue to be taken into account in the same way as they were taken into account in 2011.

The Order was made on 25th January 2012 and came into force on 26th January 2012.

"What action, if any, has the Minister taken to establish how the Tug Master hit rocks with the States Tug on 2nd September 2011?

How was the Tug Master employed, who was responsible for vetting his application and has that officer now been disciplined and, if so, how?

Has the Tug Master been replaced and, if so, by whom?

Has the Tug Master's position been re advertised on-Island as well as in Marine Journals and, if not, why not?

Why did the Minister not advise the Assembly of the result of the inquiry before the matter was made public?

Why, at of the time of submitting these questions, has no formal statement been made on the subject by the Minister?

Is cost saving taking precedence over safety at sea?

Given that the Tug Master did not hold UK qualifications will the Insurance Company honour the claim or will taxpayers have to pick up the bill?



Given that the content of the Minister's answers to questions on this matter on 12th September 2011 and 11th November 2011 indicate that he did not have a full understanding of the situation within his Department, will he consider his position and resign?"

"Will the Minister clarify whether or not the invoice in the region of £14,000 (discounted from approximately £26,000) previously sent to the Education and Home Affairs Scrutiny Panel from the company BDO Alto relating to the financial management of the Operation Rectangle Review has now been paid by Home Affairs; what date this was finally settled and, if not settled, will he advise whether he will be requesting the amount to be paid by a scrutiny panel?"

Would the Chairman advise whether the proposal was only considered by the Privileges and Procedures Committee following the Chief Minister's decision to support Senator Bailhache's desire to chair the Commission?"

- (e) details of what consultation, if any, has taken place in relation to possible pollution from this infill and the resulting loss of the view of most of St Aubin's Bay and the Noirmont headland from the east of the Island?"

"Given recent speed limit changes where many urban areas remain at 40mph whilst limits have been reduced on some rural main roads with no accident records and, in one case, a road bordered by a single house, would the Minister inform members how he ensures consistency and provide details of his current speed limit policy?"

12. The Minister for Treasury and Resources will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"What consideration, if any, has the Minister given to the introduction of a Business Property Occupation Tax and a Payroll tax to address the absence of tax revenue from zero-rated companies?

What consideration, if any, has the Minister given to the findings of the European Union's Court of Justice dated 15th November 2011, which ruled out a Business Property Occupation Tax and a Payroll tax proposed by Gibraltar on the grounds that they were materially selective and inherently favour offshore companies with little or no physical presence?

Will the Minister outline what other options, if any, he has for generating revenue from zero-rated companies?"

"What additional powers, if any, will the Chief Minister have to control population under the Control of Housing and Work (Jersey) Law 201- and how does he propose to use them?"

14. The Minister for Social Security will table an answer to the following question asked by Deputy G.P. Southern of St. Helier –

"Will the Minister inform members how many recipients of Income Support have been charged since 2008 for GP consultations instead of having clinical components and special payments?"
