Credit transactions. Questions and answers

Senator Terence John Le Main asked Senator Pierre François Horsfall, President of the Finance and Economics Committee the following questions -

Question 1

"Will the President inform the House whether his Committee intends to exercise stricter control over companies, banks, financial institutions and retailers in respect of the offering of instant credit to customers?"

The President of the Finance and Economics Committee replied as follows -

"I am not aware that there are widespread problems at present arising in this area that would justify the complex legislation that would be required to effect the control to which the Senator has referred and which does not exist in the United Kingdom legislation."

Senator Le Main

Question 2

"Will the President consider promoting legislation in relation to offers of credit facilities to protect the customer by requiring certain information to be clearly stated, e.g. monthly amounts of repayments, total cost, annual percentage rate of interest, total interest payable as a separate figure from amount of loan?"

President, Finance and Economics Committee

"Such legislation would be similar to the United Kingdom's Consumer Credit Act and would involve a considerable amount of law drafting time and several staff to administer. The legislation is intricate and not readily distilled into simpler terms. However, the majority of institutions making credit available in Jersey are United Kingdom based and often voluntarily provide such information to their customers, and I am sure it would be helpful to customers if this were to be adopted generally."

Senator Le Main

Question 3

"Will the President also consider making provision for the protection of customers by requiring the inclusion of a warning not to sign an agreement unless the customer is sure that he can afford the repayments, and provision for there to be a cooling off period during which the customer could decide not to proceed with the transaction?"

President, Finance and Economics Committee

"Provision could be made in relevant legislation for warning notices and for cooling off periods. It would be

for consideration also, however, whether these and other aspects referred to in the previous question should not be dealt with as part of a general review of consumer protection in the Island. There are numerous areas where consumer protection laws have been enacted in the United Kingdom but not followed here and much of that legislation is interconnected. It would be appropriate therefore to obtain an overview of the legislation before deciding to implement any one part of it. The wide ranging nature of the legislation would suggest that a number of Committees would be involved, and how the matter may then be progressed is something I shall be happy to discuss with the President of the Policy and Resources Committee, whom I know already has these matters under active consideration."

Visiting yachtsmen, berth and marina facilities. Questions and answers

Senator Terence John Le Main asked Senator Bernard Thomas Binnington, President of the Harbours and Airport Committee the following questions -

Ouestion 1

"Can the President inform the House of the amount of revenue derived during 1989 from visiting yachtsmen, i.e. in respect of mooring fees, shopping, restaurants, etc., and can he also confirm that Guernsey received revenue amounting to £7.9 million from such sources in the same year?"

The President of the Harbours and Airport Committee replied as follows -

"It is estimated that the amount of revenue derived from visiting yachtsmen in 1989 amounted to between #8-#9 million. This figure is calculated using the number of visiting yachtsmen and multiplying that number by a figure obtained from the Economic Adviser's office as a result of a survey of the spending patterns of the visiting yachtsmen. The figure of #7.9 million which is quoted as the revenue received by Guernsey in that year from similar

sources was obtained from a report published by the Guernsey Tourism Department and as a result of a survey conducted in that year by a company employed by them."

Senator Le Main

Ouestion 2

"Can the President inform the House how many local berths there are in all sheltered harbours and marinas in Jersey and what is the amount of the annual revenue derived from these berths?"

President, Harbours and Airport Committee

"There are 1,544 berths in local harbours and marinas allocated to local yachtsmen and the annual revenue derived during the year 1990 from these berths amounted to #81,433."

Senator Le Main

Question 3

"Can the President indicate how long it is likely to be before another marina is built in Jersey, where it will be and how many berths it will provide?"

President, Harbours and Airport Committee

"It is difficult under present circumstances to indicate how long it will be before another marina is constructed in Jersey, as this matter is presently being considered by the Island Development Committee's advisers, Andrews Downie and Partners, and will therefore be included in their report which will be debated by the States some time this year. The Harbours and Airport Committee has since 1986 had plans to construct a 1,000 yacht marina west of the Albert Pier."

Supplementary question and answer

Senator Le Main - ``Is it wise to continue to proceed with the investigation into a 1,000 yacht marina west of the Albert Pier before

coming back to this House for some indication whether this House would be in approval of building such a marina so close to Elizabeth Castle?"

President, Harbours and Airport Committee - ``The investigations were conducted in 1986 and in fact took the form of an engineering feasibility study and an Economic Adviser's economic feasibility study. No further investigations are being undertaken but the whole matter is now in the hands of the Island Development Committee and their associates and their advisers to see whether it is right for the marina to be built there or elsewhere along the south coast."

Senator Le Main

Question 4

"Will the President consider the provision of extra marina facilities as a matter of urgency to provide Jersey with an additional source of income, having regard to the recession which exists in the United Kingdom?"

President, Harbours and Airport Committee

"My Committee does consider that the provision of extra marina facilities is a matter of urgency, not only as an additional source of income but having due regard to the considerable demand for these facilities in the Island both from visitors and residents alike."

Estate agents valuation fees. Question and answer

Senator Corrie Stein asked Senator Pierre François Horsfall, President of the Finance and Economics Committee the following question -

"Will the President inform the House of the total amount of valuation fees paid to local estate agents by each Committee for the year 1990?"

The President of the Finance and Economics Committee replied as follows -

"The expenditure during the year 1990 on property valuations carried out by local estate agents amounts to #57,833 made up as follows -

Defence Committee #1,380
Public Services Committee #432
Education Committee #6,153
Public Health Committee #10,965
Social Security Committee #5,000
Island Development Committee #5,29
8
Housing Committee #27,085
Harbours and Airport Committee #1,520

The practice for such valuations in the future may well be modified, of course, by the current review being undertaken by the Policy and Resources Committee of the Land Office and Property Management Department."

Supplementary questions and answers

Senator J.S. Rothwell - `Could the President tell us how much of the expenditure in this respect by the Housing Committee totalling #27,085 is due to the exercise of price control?"

President, Finance and Economics Committee - ``I am afraid I will have to have notice of that question. I cannot answer it, the President of Housing may, but I certainly cannot, but I could at a later date."

Senator R.J. Shenton - In view of the word `local' being used in the question, were there any fees paid out to other than `local' estate agents, i.e. other valuers. We seem to have so many specialists these days coming along that I just wonder if perhaps the `local' context is, shall we say, not taking account of perhaps fees that have been paid to people based outside of the Island?"

President, Finance and Economics Committee - ``I do not know how much would have been paid, but certainly there would have been fees paid for example, to the negotiator employed by the Policy and Resources Committee on the commercial site acquisitions in the town. It would be possible to provide that answer at a later time. The question specifically related to local estate agents and I have to admit that the point made by Senator Shenton had escaped me, but certainly it has to be that there would have been some fees paid outside of the Island in relation to the acquisition of commercial sites, but also I would add that somebody asked about the Housing Committee, of course the Housing Committee would have incurred a large number of fees in relation to the site acquisitions which have been quite numerous in recent years as a result of P.57 but also other houses and properties that have been bought by the Housing Committee, I would have expected that figure to be quite high."

Senator C. Stein - ``Do we confine ourselves to one practice or do we use more and do we also pay a concessionary fee to those or that estate agent, or do we pay the normal going fees?"

President, Finance and Economics Committee - "We use a number of estate agents, they have to be professionally qualified in the skill of valuation, we have actually used five different agents in the past year to provide valuations, but these can be for various reasons, such as a speciality, for example agricultural land, you would perhaps go to a different valuer than you might if it was a commercial property, and the other thing of course, the choice of agent can sometimes be dictated by the fact that the vendor will ask for the independent valuation, it has to be independent, therefore if the vendor has himself or herself retained a valuer, then it cannot be that one, so it does mean that we have to move around a number of valuers. The fees paid are normally the scale fee, though on occasion we do have a discounted fee, but in the main they are the scale fee which is .25 of a per cent."

Public Employees Contributory Retirement Scheme: Committee of Management - appointment of member
