- Rural Economy Strategy a written progress report on the implementation of each of the recommendations made in the Panel's report SR9/2010 Rural Economy Strategy.
- Jersey Milk Marketing Board (JMMB) a briefing note from the Department on the planned dissolution of the JMMB.
- **Limited Liability Partnerships Law** a briefing note from the Department on this draft legislation.
- Shipping (Maritime Pollution) Regulations if it had not already been done, the Panel agreed to request that this legislation be sent to the Environment Scrutiny Panel for its attention.

The Panel also agreed to give further consideration at its next meeting to the Airport Review, which was presently on hold.

The Panel agreed that Deputy P.V.F. Le Claire could undertake work on the merits of scoping a future Review of Consumer Protection, and report back to the Panel accordingly.
