Detention, treatment and questioning of persons by police officers - questions and answers (Tape No. 225)

Deputy Gary Matthews of St. Brelade asked the Attorney General the following questions -

"1. Will the Attorney General inform the States what rules exist in Jersey with regard to the detention, treatment and questioning of persons by police

#### officers?

- 2. If such rules exist -
  - (a) who proposed the rules?
  - (b) by whom and under what authority were the rules issued?
  - (c) is the observance of the rules by the police voluntary or compulsory?
  - (d) what rights do the persons detained or questioned have under the rules?
  - (e) are there any requirements for bringing the rules to the attention of persons who are being detained or questioned?".

The Attorney General replied as follows -

"1. The position with regard to the detention, treatment and questioning of persons by police officers is regulated partly by statute, partly by case law and partly by Code C of the States of Jersey Police. Code C is a code of practice for the detention, treatment and questioning of persons by police officers. It is based on Code C of the Police and Criminal Evidence Act 1984 of the United Kingdom.

# Detention

No person can be detained by the police without being arrested [Melia v. Attorney General 1989 JLR, N-9].

Under Article 14 of the Loi (1864) règlant la procédure criminelle, every person who is arrested upon suspicion of having committed a crime or misdemeanour must be presented as soon as possible before the Police Court.

Once a person has been presented before the Police Court, any further detention in custody is at the Prison, and is regulated by the Prison (Jersey) Rules 1957.

#### Treatment

Treatment of persons who are in custody

during the period between the time when they are arrested and the time when they are presented before the Police Court is regulated by Code C.

# Questioning

The questioning of persons by the police is regulated by the Judges' Rules. The Judges' Rules originated in the United Kingdom. Their purpose was to give guidance to police officers in questioning suspects. They did not have the force of law, but a failure to observe the Rules could render any evidence obtained inadmissible in a subsequent prosecution.

The Royal Court has many times held, and it is now settled law, that questioning of persons by police officers in Jersey is regulated by the Judges' Rules, and that a failure to observe the Rules has the same result in Jersey as it had in the United Kingdom, that is, it renders any evidence potentially inadmissible.

In the United Kingdom, the Judges' Rules have been replaced by the provisions of the Police and Criminal Evidence Act 1984. There is no equivalent Act in Jersey, and questioning is therefore still regulated by the Judges' Rules. It is the Judges' Rules which impose the obligation to caution a suspect that he is not obliged to say anything but what he does say may be used in evidence against him.

The Judges' Rules have been incorporated into Code C at Section 10 and Annexe D.

- (a) The Judges' Rules have been adopted by decisions of the Royal Court. Code C was proposed and implemented by police administration, that is, the Defence Committee and senior officers.
  - (b) Code C was issued by police administration in pursuance of the duties conferred upon the Committee and the Chief Officer with relation to the administration and organisation of the force by the Police Force

(Jersey) Law 1974.

- (c) The issue of Code C was a voluntary act on the part of the police administration. The Code does, however, contain some provisions the observance of which is a legal requirement, for example, observance of the Judges' Rules.
- (d) It is not possible to give more than a summary of the rights conferred by Code C, which is a 50 page booklet. In outline, those rights are as follows -

A person who is detained is entitled to have a person of his choice informed of his arrest.

He is entitled to be supplied on request with writing materials. Any letter or other message shall be sent as soon as practicable.

He is entitled to speak on the telephone for a reasonable time to one person.

He is entitled to consult and communicate privately with a legal adviser.

If he asks for legal advice, he may not be interviewed or continue to be interviewed until he has received it, save in specified circumstances.

A detained person may retain clothing and personal effects unless the custody officer considers that he may use them to cause harm to himself or others, interfere with evidence, damage property or effect an escape.

Section 8 of the Code sets out conditions of detention which relate to the condition of cells, access to toilet and washing facilities, provision of refreshment etcetera.

Detained persons are entitled to medical treatment if needed.

The Code sets out special provisions in relation to

juveniles, those who are mentally ill or mentally handicapped, and those who have difficulty in understanding English.

(e) Yes. When a person is detained, he is informed of his right to have someone informed of his arrest, his right to consult privately with a legal adviser, his right to consult Code C and any other Code of Practice currently in force. He is also given a written notice setting out those rights. [Section 3.1 and 3.2 of Code C]."

the wish of the States that the trilateral Agreement on Social Security between the United Kingdom and the Isle of Man, Jersey and Guernsey should apply to Jersey.
