THE STATES commenced consideration of Regulation 4 and, adopting an amendment of the Minister for Health and Social Services (P.66/2020 Amd.), agreed that, after Regulation 3, there should be inserted the following Regulation, with the subsequent Regulations renumbered accordingly –

"4 **Summary fine**

- A Centenier may summarily inflict and levy a fine of level 1 on the standard scale on a (1) person if -
 - (a) the person is charged with an offence under these Regulations;
 - the Centenier has jurisdiction in relation to that offence; and (b)
 - (c) the person accepts the decision of the Centenier.
- (2) If a Centenier levies a fine under this Regulation –
 - (a) the Centenier must give a receipt for it;

(b) the Centenier must as soon as reasonably practicable inform the Chief Officer of the States Police Force of the details of the fine; and

(c) one half of the fine is to be retained by the parish in which the offence was committed and the other half is to be paid into the consolidated fund.".
