This Order amends the Community Provisions (Control of Exports of Dual-Use Items and Technology) (Application) (Jersey) Regulations 2002.

The 2002 Regulations apply Council Regulation (EC) No. 1334/2000 as part of the law of Jersey to the same extent as the Council Regulation applies as part of the law of the United Kingdom.

The Council Regulation has been amended by Council Regulation (EC) 1183/2007. The amendment replaces the Annexes to the 2000 Council Regulation.
