- (h) confirmation of whether or not a structured needs assessment was undertaken before the selection process was started;
- (i) the expected date on which the engagement or employment of each consultant was expected to end;
- (j) confirmation of whether or not a structured post-consultant engagement evaluation was undertaken;
- (k) confirmation of whether or not the contract had been, or was expected to be, extended; and
- (1) the title of the accounting officer responsible for the engagement.
