DRAFT HARBOURS (AMENDMENT No. 39)(JERSEY) REGULATIONS 200-

REPORT

In order to make best use of open space for working and moving items through the Harbours, there is a system of Quay Inspection which, where items stay beyond a prescribed free period, a daily fine is imposed.

There are no manpower implications and the financial implications are as follows.

In order to maintain the effectiveness of this sanction it is proposed that the fines be increased by 3.6% (Jersey Retail Price Index).

Explanatory Note

The effect of these Regulations would be to increase by 3.6% the daily charges for goods that remain on a harbour for longer than the period specified in Part 1 of Schedule 1 to the Harbours (Jersey) Regulations 1962.

The Regulations would come into force on 1st January 2006.

THE STATES, in pursuance of Article 4 of the Harbours (Administration) (Jersey) Law 1961,^[1] have made the following Regulations –

1 Schedule 1 amended

For Part 2 of Schedule 1 to the Harbours (Jersey) Regulations 1962^[2] there shall be substituted the Part set out in the Schedule to these Regulations.

2 Citation and commencement

- (1) These Regulations may be cited as the Harbours (Amendment No. 39) (Jersey) Regulations 200.
- (2) These Regulations shall come into force on 1st January 2006.
