This Amendment increases harbour dues for arriving and departing passengers and imported and exported goods, fuel oil shipped in bulk, and vehicles carried on "drive-on/drive-off" ferries and certain dues charged in respect of mooring space.

Harbour and Light Dues (Jersey) Law 1947

AMENDMENT (No. 21) TO THE TARIFF OF HARBOUR AND LIGHT DUES

THE HARBOURS AND AIRPORT COMMITTEE, in pursuance of Article 6 of the Harbour and Light Dues (Jersey) Law 1947, as amended,¹ and with the approval of the States given on [] 1998, has made the following amendment to the Tariff of Harbour and Light Dues approved by the States on the nineteenth day of August 1980² (hereinafter referred to as “the Tariff”) -

1. In Part I of the Tariff³ in the definition of “overall length” in paragraph 1 the words “to an accuracy of two decimal places” shall be deleted.

2. For Part III of the Tariff there shall be substituted the following -

“PART III

HARBOUR DUES

A. Dues payable on arrival and on departure

1. For each passenger disembarked from or embarked on a ship -

(a) adult	£1.64
(b) child	82p

with a reduction for each passenger bound for or from a port within 55 nautical miles of the Port of Saint Helier of 16p an adult

and 8p a child

2. For each private vehicle disembarked from or embarked on a “drive-on/drive-off” ferry accompanied by a driver £6.35
3. Where the following are disembarked from or embarked on a “drive-on/drive-off” ferry for each commercial trailer -
 - (a) whose overall dimensions do not exceed 3 metres in length, 2.5 metres in width and 2.5 metres in height £2.31
 - (b) whose overall length exceeds 3 metres but does not exceed 10 metres £10.20
4. Where the following are disembarked from or embarked on a “drive-on/drive-off” ferry for each -
 - (a) trade car £10.20
 - (b) commercial vehicle (other than a commercial trailer to which paragraph 3 applies) £10.20
 - (c) commercial vehicle (other than a commercial trailer to which paragraph 3 applies) whose length exceeds 10 metres £10.26
 - (d) private vehicle not accompanied by a driver £10.20
5. For each metric tonne net of
 - (a) fuel oil shipped in bulk,
 - (b) mail, or

(c) other goods

unloaded from or loaded into a ship £6.26

6. Where at any harbour in the Island -

(a) any passenger travelling to a destination outside the Island disembarks from a ship and for the purpose of continuing his journey embarks on another ship;

(b) any car, trailer or vehicle described in paragraphs 2 to 4 being shipped to a destination outside the Island is disembarked from a “drive-on/drive-off” ferry and for the purpose of continuing its shipment is embarked on another “drive-on/drive-off” ferry; or

(c) any fuel oil, mail or goods described in paragraph 5 being shipped to a destination outside the Island is unloaded from a ship and for the purpose of continuing its shipment is loaded on another ship;

the appropriate dues payable under paragraph 1, 2, 3, 4 or 5 shall be reduced by 50%.

B. Dues payable in respect of mooring space

1. Ship owned by person ordinarily resident in Jersey moored at -

(a) Saint Helier Harbour (excluding La Collette Yacht Basin, Upper Harbour Yacht Marina,

- Elizabeth Marina and the holding pontoon at No. 5 berth) or the inner harbour at Saint Aubin - for each year or part of a year, £7.38 a square metre, or part thereof, of the superficial area of the ship with a minimum charge of £39.52;
- (b) the inner harbour at Gorey - for each year or part of a year, £6.36 a square metre, or part thereof, of the superficial area of the ship with a minimum charge of £32.24;
- (c) the harbour at Bonne Nuit Bay, Bouley Bay or Rozel - for each year or part of a year, £3.27 a square metre, or part thereof, of the superficial area of the ship with a minimum charge of £17.39;
- (d) Belcroute Bay, Saint Catherine's Harbour, La Rocque, Saint Brelade's Bay or the outer moorings at Saint Aubin - for each year or part of a year, £1.62 a square metre, or part thereof, of the superficial area of

the ship with a minimum charge of £8.74.

All the dues referred to in this paragraph shall be paid annually in advance.

2. Single-hulled ship owned by person ordinarily resident in Jersey moored at La Collette Yacht Basin -

(a) for each day or part of a day

ship under 8 metres' overall length, £9.00 paid in advance, otherwise £11.00;

ship of 8 metres or more, but under 10 metres' overall length, £11.00 if paid in advance, otherwise £13.00;

ship of 10 metres or more, but under 12 metres' overall length, £13.00 if paid in advance, otherwise £15.00;

ship of 12 metres or more, but under 14 metres' overall length, £15.00 if paid in advance, otherwise £17.00;

ship of 14 metres or

more, but under 16 metres' overall length, £20.00 if paid in advance, otherwise £22.00;

ship of 16 metres or more, but under 20 metres' overall length, £28.00 if paid in advance, otherwise £30.00;

- (b) for each week if paid in advance six times the daily rate;
- (c) for each month or part of a month during the period from 1st October to 30th April in any year an amount equal to the product of £14.00 and the overall length of the ship;
- (d) for the period from 1st October to 31st December in any year if paid in advance an amount equal to the product of £33.00 and the overall length of the ship;
- (e) for the period from 1st January to 30th April in any year if paid in advance an amount equal to the product of £44.00 and the

overall length of the ship;

(f) for the period from 1st November to 30th April the following year if paid in advance

an amount equal to the product of £54.00 and the overall length of the ship;

(g) for the period from 1st October to 30th April the following year if paid in advance

an amount equal to the product of £63.00 and the overall length of the ship;

(h) for any period of 12 months if paid quarterly in advance

for a ship under 5.2 metres' overall length not having an individual berth, an amount equal to the product of £128.20 and the overall length of the ship;

for a ship under 5.2 metres' overall length having an individual berth, or a ship of 5.2 metres or more overall length, an amount equal to the product

of £198.50 and the overall length of the ship;

3. Ship, other than a single-hulled ship, owned by a person ordinarily resident in Jersey, moored at La Collette Yacht Basin -

the dues specified in paragraph 2, as appropriate, plus 50%.

4. Single-hulled ship moored at Upper Harbour Yacht Marina or the holding pontoon at No. 5 Berth, or, where paragraph 2 is not applicable, at La Collette Yacht Basin -

- (a) for each day or part of a day

ship under 8 metres' overall length, £11.00;

ship of 8 metres or more, but under 10 metres' overall length, £13.00;

ship of 10 metres or more, but under 12 metres' overall length, £15.00;

ship of 12 metres or more, but under 14 metres' overall length, £17.00;

ship of 14 metres or more, but under 16 metres' overall length, £22.00;

ship of 16 metres or more, but under 20 metres' overall length, £30.00;

- (b) for each week if paid in advance six times the daily rate;
- (c) for each month or part of a month during the period from 1st October to 30th April in any year the due specified in paragraph 2(c);
- (d) for the period from 1st October to 31st December in any year if paid in advance the due specified in paragraph 2(d);
- (e) for the period from 1st January to 30th April in any year if paid in advance the due specified in paragraph 2(e);
- (f) for the period from 1st November to 30th April the following year if paid in advance the due specified in paragraph 2(f);

- (g) for the period from 1st October to 30th April the following year if paid in advance the due specified in paragraph 2(g);
- (h) for any period of 12 months if paid quarterly in advance £192.07.
5. Single-hulled ship moored at Elizabeth Marina -
- (a) for each day or part of a day the dues specified in paragraph 4(a) as appropriate;
- (b) for each week if paid in advance six times the daily rate;
- (c) for each month £22.50 a metre or part of a metre of overall length if paid at least 3 months in advance, otherwise £25.00 a metre or part of a metre of overall length;
- (d) for any period of 12 months if paid quarterly in advance £184.68.

6. Ship, other than a single-hulled ship, moored at Upper Harbour Yacht Marina, Elizabeth Marina or the holding pontoon at No. 5 Berth, or where paragraph 3 is not applicable, at La Collette Yacht Basin - the dues specified in paragraph 4 or 5, as appropriate, plus 50%.
7. Commercial shipping using St. Helier Harbour not paying any other due in respect of cargo or passengers, or any other craft not occupying an allocated mooring, for each day or part of a day £1.50 a metre or part of a metre of overall length.
8. Ship moored on a pontoon at the end of the New North Quay
- (a) if owned by a person ordinarily resident in Jersey, for a stay not exceeding 12 hours in any period of 36 hours nil;
- (b) otherwise, for each day or part of a day £4.50 in respect of the first three days of its stay, thereafter £13.30.

9. Ship owned by a person not ordinarily resident in Jersey moored at a place other than La Collette Yacht Basin, Upper Harbour Yacht Marina, Elizabeth Marina or the holding pontoon at No. 5 Berth, other than a ship to which paragraph 7 or 8 applies, for each day or part of a day -
- ship under 8 metres' overall length, £6.00;
 - ship of 8 metres or more, but under 10 metres' overall length, £7.00;
 - ship of 10 metres or more, but under 12 metres' overall length, £8.00;
 - ship of 12 metres or more, but under 14 metres' overall length, £9.00;
 - ship of 14 metres or more, but under 20 metres' overall length, £10.00;
 - ship of 20 metres or more, but under 25 metres' overall length, £13.00.

10. Ship laying up in Jersey, for each day or part of a day -
- ship under 6 metres' overall length, £1.54
 - ship of 6 metres or more but less than 9 metres' overall length, £2.27
 - ship of 9 metres or more but less than 15 metres' overall length, £3.52
 - ship of 15 metres or more but less than 30 metres' overall length, £5.93
 - ship of 30 metres or more overall length, £8.90
11. Ship moored at the Working Berths at the French Harbour at St. Helier, for each week or part of a week
- £6.76 a square metre, or part thereof, of the superficial area of the ship.”.

3. This Amendment comes into force on the first day of January 1999.
