#### Report

The continuing effect of the tightening of the Island's job controls is seen in the results of the manpower survey for 31st March 1999 which shows an overall reduction of 332 in full and part-time posts during the year.

The total number of persons engaged full-time by undertakings fell by 38 over the twelve months from 31st March 1998 to 36,056 at 31st March 1999, a decrease of 0.1 per cent.

The largest percentage decrease in total numbers engaged full-time occurred in the construction sector (-9.7 per cent) - nearly half of these reductions caused by the completion of long-standing civil engineering contracts. The next largest decline was the legal activities sector (-2.4 per cent) and the manufacturing sector (-1.3 per cent). The largest increases were in the real estate/other business activities sector (ten per cent) and the banking sector (5.1 per cent).

The total number of persons engaged part time by undertakings fell by 294 over the twelve months from 31st March 1998 to 8,069 at 31st March 1999, a decrease of 3.5 per cent.

Overall, 44,125 people were engaged in full or part-time work at the end of March, 332 (0.75 per cent) fewer than a year earlier. The biggest declines occurred in the construction and trades sectors, where 770 fewer persons were employed, while the finance industry provided the biggest growth, accounting for 336 new jobs (271 of them in banking). Other growth sectors included health and social services, transport and general business activities, whilst declines were also seen in agriculture and fisheries, and tourism.

Considerable effort has gone into contacting employers to ensure that manpower returns are correct and the result is that the figures are the most accurate so far obtained. They therefore provide an excellent basis on which to assess future figures (which will from now on will be audited by the Head of Statistics within the Policy and Resources Department) but it makes it difficult to draw other than broad conclusions when compared with the figures from previous surveys.
