#### REPORT

**Decision(s):** Under Standing Order 168(3) the Minister for Treasury and Resources hereby notifies the States that he has accepted the recommendation of the Property Holdings Department to agree to the following –

### (a) Land transaction -

To rescind MD-PH-2006-0005 which was not implemented, and to approve updated terms and conditions in respect thereof.

To agree to the surrender of the existing 9 year lease with Starfish Limited and enter into a new lease of 25 years for the property known as Grève de Lecq Café Site No. 2, St. Ouen with a commencing rental £8.750.00 a year.

The Minister hereby authorises the Attorney General and the Greffier of the States to pass any contract which is required to be passed on behalf of the Public.

After the expiry of 15 days following presentation to the States the transaction may be concluded.
