### **R&O.10/2025.**

Income Tax Law (Jersey) Amendment Order 2025.

*Minister for Treasury and Resources.*

This Order amends Schedule 5 to the Income Tax (Jersey) Law 1961 (“the Law”) to re-insert paragraph 13, which disapplies the definition “distribution” in Article 3AE of the Law to prevent tax under Case V of Schedule D being charged in relation to things that were not chargeable to income tax before 2013. The Order comes into force on the day after it is made.

The Order was made on 25th February 2025 and came into force on 26th February 2025.

This Order amends the Education (Grants and Allowances) (Jersey) Order 2018 (the “2018 Order”) to –

- increase by 5.2% the thresholds for a student’s relevant income for the 2025 academic year;
- increase by 3.1% the tuition fees grant payable to students for the 2025 academic year; and
- increase by 2.5% the maintenance grant and clinical component grant payable to students for the 2025 academic year.

*Article 1* states that this Order amends the 2018 Order.

*Article 2* inserts a definition of “2025 academic year” into Article 1 of the 2018 Order, and amends the definition of “relevant income so that it also applies to Article 12A.

*Article 3* amends Article 12 so that the meaning of “maintenance grant” includes grants awarded under new Articles 13BA and 13CA.

*Article 4* amends Article 12A to increase, for the 2025 academic year, the amount of income attributed to a student if the value their relevant assets is more than £500,000.

*Article 5* amends Article 13 to increase the thresholds for a student’s relevant income, and to increase tuition fees grants, for the 2025 academic year.

*Article 6* substitutes Article 13B and inserts a new Article 13BA. The replacement Article 13B states the maximum maintenance grant (which is payable to students whose relevant income is less than £50,000) for only the 2024 academic year. The new Article 13BA increases the income threshold for payment of the maximum maintenance grant to £52,600, and states the maximum maintenance grant, for the 2025 academic year.

*Article 7* amends Article 13C so that it applies only to the 2024 academic year.

*Article 8* inserts a new Article 13CA, which –

- states the minimum maintenance grant for the 2025 academic year;



- gives the formula used to calculate the amount of maintenance grant payable to students whose relevant income is between £52,600 and £94,679.99; and
- gives an example of how the formula is used to calculate the amount of maintenance grant payable.

*Article 9* amends Article 15 so that the increases applied to the clinical component grant and relevant incomes for the 2025 academic year are now included in that Article (in addition to the existing figures for the 2024 academic year).

*Article 10* amends Article 20A so that the meaning of “full amount of the maintenance grant” includes grants awarded under new Articles 13BA and 13CA.

*Article 11* amends Article 22 to allow an interview attendance allowance to be paid to a student with relevant income of up to £52,599 in the 2025 academic year (from the previous £49,999 for the 2024 academic year).

*Article 12* amends Article 23 to increase the income threshold at or above which a disabled student allowance is not payable to £94,680 for the 2025 academic year.

*Article 13* gives the title of the Order and states that it comes into force 7 days after it is made.

The Order was made on 27th February 2025 and came into force on 6th March 2025.



## **Explanatory Note regarding Appointment of unelected members to the Public Accounts Committee.**

Throughout his career, Ali has worked extensively with public and private sector entities, investment funds, and financial institutions, conducting audits, regulatory reporting, and financial reviews. He has engaged directly with boards, compliance teams, and risk committees to ensure transparency, accountability, and strong financial controls. His experience includes reviewing financial information, assessing internal controls, and advising on risk management frameworks to strengthen governance and compliance.

Ali has a deep understanding of Jersey's financial and regulatory landscape, having worked on financial reporting, governance requirements, and regulatory audits. His ability to analyse complex financial data (including budgets and expenditures), assess risks, and provide independent oversight makes him well-positioned to contribute to the work of the Public Accounts Committee, ensuring effective scrutiny of public finances and accountability in financial decision-making.

- (g) an emergency caesarean section;
- (h) a home birth (low risk pregnancy/low intervention/vaginal birth);
- (i) a hospital birth (low risk pregnancy/low intervention/vaginal birth); and
- (j) an induced vaginal birth in hospital?”



**Explanatory Note regarding the main respondents for items listed under Public Business**  
(Item L)

In accordance with Standing Order 104A, a time limit of 15 minutes applies to speeches made during debate, unless discretion has been exercised to allow for a longer, or shorter, time limit. No time limit applies to either speech made by the proposer.

Discretion is exercised by the Presiding Officer in accordance with guidance issued by the Bailiff, following consultation with the Privileges and Procedures Committee. The current guidance was presented to the States in the report ‘Time Limits on Speeches in Debates: Guidance on the Exercise of Discretion’ (R.3/2021). The report states that discretion may be exercised to allow for a longer speech than 15 minutes where the member speaking is designated as the ‘main respondent’ to the debate.
