The Panel discussed the Food (Jersey) Law 2003 and noted that the Minister for the Environment had made the Panel aware that the law was in the legislative pipeline. In the first instance, the Panel agreed its intention to focus the workstream on stakeholder engagement in respect of the proposals potential impact.

The Panel discussed the Amendment to the Highways (Jersey) Law 1956 regarding election advertisements. The Panel noted that the Privileges and Procedures Committee had received a briefing on the matter recently and raised concerns of a potential overlap. However, the Panel noted that the Minister for Infrastructure was responsible for the legislation and it would therefore fall under the Panel's remit.

The Panel considered the matter of legislation to improve access to information relating to energy resilience and noted that it had been due to receive further information in early 2025. The Panel agreed to wait for the information to be shared with it before considering the workstream further.

The Panel was welcomed to Union Street by the Head of Strategic Housing and Regeneration and the Principal Regeneration Officer for a demonstration of the interactive screens which had been developed to assist public understanding of the Plan for Town.
